“SHOULD THE WISCONSIN LEGISLATURE CREATE A NONPARTISAN PROCEDURE FOR THE PREPARATION OF LEGISLATIVE AND CONGRESSIONAL DISTRICT PLANS AND MAPS? YES NO”

Proposed message

On **June 17**, please **vote YES to let Brown County voices be heard in November!** I want the November ballot to include the question about nonpartisan redistricting so we can tell the state to take a more fair and cheaper approach to prepare legislative and congressional district plans.

Here are a few reasons to support such a referendum for Brown County voters:

- People in both parties (72% of all voters) favor finding a nonpartisan way to draw district lines (according to a 2019 Marquette University poll).
- Nonpartisan redistricting reduces costly lawsuits (\$ millions!) and encourages good candidates from all parties to run (since the outcome isn't "predetermined").
- Since 1980, Iowa has had nonpartisan staff draw the lines with a nonpartisan approach with no litigation/lawsuits!

- Similar referendums conducted in other counties across the state typically show bipartisan support of at least 70% of voters!* This shows that a majority of Wisconsinites want to ban gerrymandering and bring nonpartisan redistricting to Wisconsin.

Please vote in support of adding the question so Brown County constituents will also be allowed to tell our State leaders that we want nonpartisan redistricting in 2021!
