GENERAL INSTRUCTIONS:

1. Terms of office for all officers shall be July 1 to June 30 of each year. The terms of officers will be two (2) years. The President is limited to three (3) consecutive two (2) year terms. The President and Vice Presidents will be elected in even numbered years. Zone leaders and the ESP At-Large representative shall be elected at the Annual Representative Assembly to serve one (1) year terms.

3-3 Duties of Officers**A. President**

1. Shall represent the Region at meetings and before the public as necessary.
2. Shall be a voting member of the Executive Committee.
3. Shall chair the Executive Committee and Representative Assembly meetings.
4. Shall be an ex officio member of all other Region Committees.
5. Shall appoint the membership on all Standing Committees, minority guarantee, and new educator at large, with approval of the Executive Committee.
6. If a delegate, shall Chair the Region Caucus at the WEAC Representative Assembly.
7. Shall approve vouchers submitted by the Treasurer, and approve all vouchers in the absence of the Treasurer.
8. Shall approve staff leaves.
9. Shall arrange for orientation for all newly elected officers and Executive Committee members as to their duties and responsibilities on the Board.
10. Shall serve on the WEAC Board of Directors.
11. Shall make arrangements to meet the significant time commitments of managing the staff and meeting all responsibilities of the office.

B. Vice Presidents**Vice President A**

1. Shall chair meetings in the absence of the President.
2. Shall carry out the duties assigned by the President.
3. Shall be a voting member of the Executive Committee.
4. Shall be prepared to take the place of the president if the president is no longer able to serve.
5. Shall be a liaison to Standing Committees as directed by the president.

Vice President B

1. Shall chair meetings in the absence of the President and Vice President A.
 2. Shall carry out the duties assigned by the President.
 3. Shall be a voting member of the Executive Committee.
 4. Shall be prepared to take the place of Vice President A if Vice President A is no longer able to serve or secedes to the presidency.
 5. Shall be a liaison to Standing Committees as directed by the president.
2. Candidates filing nomination forms postmarked by May 5, 2018 (one week prior to the annual meeting of the Representative Assembly) shall have their names on the printed ballot.
 3. Additional candidates may be nominated from the floor of the Representative Assembly at the time designated on the agenda.
 4. **All nominees for election to the Board of Directors must be delegates in attendance to the WEAC Region 3 Representative Assembly.**
 5. Persons qualified for office and holding membership in a member local association may request a nomination form from the WEAC Region 3 office. The nomination form shall require the signature of the candidate and a nominator.

We come under federal law. Dues money cannot be used to promote the candidacy of our members. This means that a local cannot give any money to a candidate nor can a local print campaign material for a candidate. The candidate has to seek voluntary contributions or fund his/her own candidacy.
