Only Active Government Individual, Government Group, and Retired Members may vote (see Bylaws, Article III, Section II).

Voting will occur via a disinterested third party electronic service. Every Voting Member will be assigned a unique "Voting ID" number for this election. *This is different from your Membership number!* The TEMA office will contact Voting Members to provide the Voting ID number and instructions on how to vote via email (or phone, if email address is lacking or not working) after the Record Date listed above.

IMPORTANT: Every reasonable attempt will be made to notify Voting Members via the contact information provided on your membership application. Please ensure an email from this address is received by your server and/or not relegated to your spam mailbox.
