RE: Institutional Review Board Fees on Industry Sponsored Studies

Dear Health Science Deans, Department Chairs, Principal Investigators, and Clinicians:

In response to increasing costs associated with growing regulatory demands connected with clinical research endeavors, fees associated with reviews of industry sponsored clinical trials involving human subject research protocols at West Virginia University and their affiliates will be updated. These changes will become effective July 1, 2019. The Human Research Protection Program staff have determined that the new fees are consistent with the fee-for-service model used by other organizations. The changes have also been discussed with the leader of WVU's Center of Excellence in Clinical Trials.

Please note that these fees apply only to industry sponsored trials. Investigator initiated protocols that are not industry sponsored will not be charged review or administrative fees by the WVU IRB.

The revised fee schedule will include review and administrative fees on initial reviews, continuing reviews, amendments, study closures, notifications, HIPAA waivers, and "rush" reviews on all protocol submissions for industry sponsored studies.

Attached to this memorandum is the *WVU Human Research Protection Program Fee Schedule for Industry Sponsored Studies effective July 1, 2019* for your documentation.

In addition, initial invoices will be issued by the Human Research Protection Program following receipt of a protocol unless other billing arrangements exist with individual departments and/or groups. If the invoice has not been paid within 45 days, the amount of the unpaid balance will be assessed against a college, school, or unit account to reimburse the Human Research Protection Program.

In closing, thank you for your commitment to the continued success of the research enterprise at West Virginia University.
