The Central California Chapter of CAAEYC is organizing an art display in honor of the Week of the Young Child held in April of 2020. The Week of the Young Child is an annual celebration hosted by the National Association for the Education of Young Children (NAEYC) where we celebrate early learning, young children, their teachers, and their families.

In honor of the event we will be showcasing children's artwork from the early education communities located within Fresno, Madera, Mariposa, Kings, and Tulare counties. We would like to invite you to submit process artwork from the children in your early childhood education program.

Both two-dimensional and three-dimensional art pieces are encouraged for this event. The art display will highlight child-created, individualized, process art. Therefore, in order for your submitted artwork to be used in the display, the pieces will have to be some form of child-created process art. Below you will find characteristics of what process-focused art is, as highlighted in Laurel Bongiorno's article in the Vol. 7, No. 3 edition of Teaching Young Children:

Characteristics of process-focused art experiences:

- There is no step-by-step instructions
- There is no sample for children to follow
- There is no right or wrong way to explore and create
- The art is focused on the experience and exploration of techniques, tools, and materials
- The art is unique and original
- The art experience is relaxing or calming
- The art is entirely the children's own
- The art experience is a child's choice
- Ideas are not readily available online

How to Submit: If you would like to submit your student's art for this display, please do so during the week of *March 23 – 27, 2020*. The art pieces may be mailed or dropped off in person to the Central Valley Children's Services Network located at 1911 N. Helm Ave, Fresno, CA 93727. If mailing in the art work, please indicate, "ATTN: Public Relations" on the package. Attached to this letter is a description page and student labels that need to be submitted with the artwork.

*Art will be displayed at **Sierra Vista Mall** during the month of April 2020. We encourage you to invite the children and families from your program to view the art display at their convenience.*

Art Pick-up: *The artwork will be taken down on May 1, 2020. If you choose to submit artwork for the display, you must send a representative from your center to collect the artwork on May 1, 2020 between the hours of 3pm-6pm. Any artwork not collected by 6pm will be disposed of.*
