The undersigned is informed and believes that:

COUNT 1

On or about September 11, 2019, in the County of Los Angeles, the crime of BATTERY WITH SERIOUS BODILY INJURY, in violation of PENAL CODE SECTION 243(d), a Felony, was committed by EDWARD PETER BUCK, who did willfully and unlawfully use force and violence upon the person of JOE DOE, resulting in the infliction of serious bodily injury on such person.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

COUNT 2

On or about September 11, 2019, in the County of Los Angeles, the crime of SALE/OFFER TO SELL/TRANSPORTATION OF A CONTROLLED SUBSTANCE, in violation of HEALTH AND SAFETY CODE SECTION 11379(a), a Felony, was committed by EDWARD PETER BUCK, who did unlawfully transport, import into the State of California, sell, furnish, administer, and give away, and offer to transport, import into the State of California, sell, furnish, administer, and give away, and attempt to import into the State of California and transport a controlled substance, to wit, methamphetamine.

"NOTICE: Conviction of this offense will require you to register pursuant to Health and Safety Code section 11590. Failure to do so is a crime pursuant to Health and Safety Code section 11594."

COUNT 3

On or about September 11, 2019, in the County of Los Angeles, the crime of MAINTAINING PLACE FOR SELLING OR USING CONTROLLED SUBSTANCE, in violation of HEALTH AND SAFETY CODE SECTION 11366, a Felony, was committed by EDWARD PETER BUCK, who did unlawfully open and maintain a place for the purpose of unlawfully selling, giving away, and using a controlled substance, to wit, Methamphetamine.

"NOTICE: Conviction of this offense will require you to register pursuant to Health and Safety Code section 11590. Failure to do so is a crime pursuant to Health and Safety Code section 11594."

* * * * *

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and *Cunningham v. California* (2007) 549 U.S. 270.

NOTICE: A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR.

NOTICE: Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.

NOTICE: Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form (“PPR”) pursuant to Penal Code § 29810.

Further, attached hereto and incorporated herein are official reports and documents of a law enforcement agency which the undersigned believes establish probable cause for the arrest of defendant(s) EDWARD PETER BUCK for the above-listed crimes. Wherefore, a warrant of arrest is requested for EDWARD PETER BUCK.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT AND THAT THIS COMPLAINT, CASE NUMBER BA481154, CONSISTS OF 3 COUNT(S).
