New Cardiology Advanced Care Planning SmartForm

In order to support the Cardiovascular Service Line goal to increase Advanced Care Planning for adult CHF patients, we have embedded the new SmartPhrase .cardacp at the end of the Cardiac Discharge Summary [MH IP Cardiac Discharge Summary].

The .cardacp SmartPhrase is also available for use in the standard HF clinic note template in order to support coordinated advanced care - care that is demonstrated to improve quality of life and outcomes for these complex patients.

When using this documentation tool, the specific advanced care planning note content will automatically flow into the Advanced Care Planning tab in SeHR/Epic and will populate the ACP Note section.
