Fields of study include, but are not limited to: construction technology, project management, architecture, engineering, and project/construction management.

Applications for the **Colton D. Harper Memorial Scholarship** **MUST** be filed by July 1, 2019, together with a complete copy of your high school transcript (through the completion of your Senior year), and the indication of results of any college entrance exams which you have taken. If you are already enrolled in college, submit a college transcript of **ALL**, college courses taken to date (including Spring 2019 courses).

Also, applicants must submit a written essay (no more than 600 words) on “why you are interested in the construction industry as a career.”

(PLEASE NOTE: High school and college transcripts do not need to be “official” transcripts, a copy will be fine.)
