**Vice President for Membership and Publications** (one year term) In this position you are involved in several committees, with leadership for Membership and SLA's Communications, as well as sitting on the Executive with responsibility for Finance.

**Vice President for Advocacy and Development** (two year term) In this position you are involved in several committees, with leadership for Advocacy and SLA's Programs, as well as sitting on the Executive with responsibility for Personnel.

**Vice President for Advocacy and Development** (two year term)

**Member at Large** -two positions available (two year terms) In these positions, you become involved in learning the ins and outs of board activities, participate in at least 2 committees, and engage in various decisions and initiatives of the board.
