AWARD:

To be presented annually by the Abington School Committee to a teacher and educational support person who by her/his performance has demonstrated a willingness to assume responsibilities and perform deeds well above and beyond those normally expected, thereby distinguishing them by their great examples, dedication, perseverance, and commitment to helping students.

NOMINATION PROCESS

Nomination packets can be found at the bottom of this notification. Nominations need to be completed and submitted no later than **Friday**, **April 17**, **2020** via email only to debrakeough@abingtonps.org (due to COVID-19 and buildings being closed, paper copies will not be accepted).

Please use a <u>separate</u> nomination packet for each individual educator, instead of one packet for multiple educators or departments. For example, if you would like to nominate all the teachers in a particular department, please use and submit a separate nomination packet for each individual teacher in that department. Use the allotted space provided under each question to write your answer.

SELECTION PROCESS

A committee consisting of representatives of the Abington Public School Principals, the Abington Education Association (AEA), and the Parent Teacher Organization (PTO) will meet at the end of April to review nomination packets submitted for each candidate. The committee will review the nominations through an anonymous process. The anonymous process has teacher and educational support personnel names removed prior to review by the committee in order to eliminate bias and ensure equity in the review process for each candidate. Based upon merits written, the committee will then select one teacher and one educational support personnel candidate to receive each award. The School Committee will confirm the nomination at a spring School Committee meeting. Awards will be announced during Teacher Appreciation Week in May.
