- **Eligibility Requirements: Home must be in the City of Sarasota.**
- **Total household income must be at or below 80% of median income adjusted by household size.**
- **The elderly, disabled, and those homeowners at or below 50% of area median income will receive priority.**
- **Homes must be built between 1978 and 2001, and does not meet 2001 edition of Florida Building Code. Manufactured homes and homes with significant structural issues are not eligible.**
- **Property taxes, mortgage and insurance must be current. No liens on the property other than mortgage, hospital or utility.**
- **Homes must be single-family, owner occupied residences with a maximum value of \$272,195 as determined by the Sarasota County Property Appraiser. You must hold fee simple title or life estate in the property, reside in the property, and have a current homestead exemption.**
- **Maximum assistance is \$35,000 in the form of a grant. Funds must be used for windows, doors, and roofs. Homes that have significant structural issues which cost more to repair than the value of the home will not be eligible. If the home does not meet Housing Quality Standards established by HUD, OHCD will advise the homeowner of other rehabilitation programs offered by OHCD.**
- **Registration will not guarantee participation in the program. The Florida Division of Emergency Management makes final determination of selected properties.**
- **Names will be randomly shuffled via computer.**
- **The homeowner is responsible after mitigation to seek any premium discounts that may be available from their insurer. Stickers must be left on manufactured items until final form OIR-B1-1820 is complete.**
