David Atkin works with nonprofit organizations throughout the United States and internationally including locations such as Asia and Latin America. He regularly presents educational programs on nonprofit law for charitable organizations, universities, political organizations and churches.

Cynthia is a retired attorney who worked with thousands of nonprofit organizations in her 38 years as a lawyer and workshop leader. She is the co-author of "The Oregon Nonprofit Corporation Handbook", now in its 5th edition, which is widely used by Oregon nonprofits and the professionals who serve them. She also wrote numerous chapters on nonprofit law for the Oregon State Bar and taught the first law school classes in Nonprofit Law in Oregon.

Katherine DeYoung, Certified Public Accountant

Katherine is a CPA who has worked extensively with nonprofit organizations throughout her 30+ year accounting career. She is the founder of the Center for Nonprofit Stewardship and led that organization for 15 years and is co-founder of Nonprofit Board Training & Resources. In addition, she is the author of "A Toolkit for Writing Nonprofit Financial Policies" and a "Nonprofit Internal Audit Workbook."

Kirk Harvey, CFE, Oregon Department of Justice, Charitable Activities Section (retired)

Kirk was the Chief Investigator for the Charitable Activities Section of the Oregon Department of Justice. He is a Certified Fraud Examiner with over 30 years of experience in nonprofit governance regulation and auditing. He holds an MPA in Nonprofit Management from Portland State University and is the President of Nonprofit Board Training and Resources.

Alexis James, Director, Training & Organization Development, Cascade Employers Association

Alexis is a longtime educator and innovator. She supports Cascade members in activating contemporary responses to leadership development and employee needs through training, coaching, and team building. Currently Joe works nationally to develop outreach systems that reduce the struggle to comply with complex tax laws.

Kay Sohl, Consultant, Kay Sohl Consulting

Kay has provided training and consultation for Executive Directors, CFOs, and Boards of Directors of over 7,000 nonprofit organizations throughout the United States. She founded and led Technical Assistance for Community Services (now known as the Nonprofit Association of Oregon). Kay is also co-author of the "Oregon Nonprofit Corporation Handbook," which has sold over 11,000 copies.
