

As more parishes seek worship and faith formation resources during the COVID-19 pandemic, Church Publishing Incorporated (CPI) is working to ease that process by sharing our current permissions guidelines and practices. ### ***Music and the hymnals –***

- Church Publishing can give permission to use only those hymns for which the Church Pension Fund or CPI owns the copyright. Though as of this writing *Hymnal 82* does not appear specifically in the list of hymnals covered by One License, our hymns do appear individually.
- Church Publishing Incorporated grants permission for performances of hymns found in *Hymnal 82*, *Wonder, Love and Praise*, and *Lift Every Voice and Sing II* that are either listed as in Public Domain or whose copyrights are owned by Church Publishing Incorporated or The Church Pension Fund to be streamed for virtual corporate worship. This permission is limited to congregational use only and only until **November 22, 2020**. The standard requirement to obtain permission for the use of these hymns from Church Publishing Incorporated will return after this date. Permission to stream these hymns requires that attribution (composer, lyricist, copyright owner or manager) be given and permission noted and that the hymn be removed from all sites three weeks after posting the service.
- We cannot give permission on those hymns for which we do not own copyright. Please check with the rights holders or One License. (A full list of copyright owners may be found in the back of *Hymnal 82* beginning on page 930; for *Wonder, Love, and Praise* on page 243, and at the bottom of each page in *Lift Every Voice and Sing II*)

- For print congregational use: Subscriptions are available to *RiteSong*, an online music library for hymns and other liturgical music ([riteseries.org/song/](http://riteseries.org/song/)), with permission to use all material available through the program. Please note that this permission is for bulletin creation and not music streaming. Likewise, subscriptions to the deluxe version of *RitePlanning*, a customizable worship planning tool ([churchpublishing.org/riteplanning](http://churchpublishing.org/riteplanning)), include permission for hymns and other music to be reproduced for use in a bulletin or service leaflet but does not offer permission for music streaming.
- OneLicense.net offers a podcast / streaming license, if that's the appropriate choice for your parish.

Church Publishing Incorporated grants permission for other liturgical texts (*Enriching Our Worship*, etc) to be streamed for virtual corporate worship. This permission is limited to congregational use only and only until **November 22, 2020**. The standard requirement to obtain permission from Church Publishing Incorporated will return after this date. Permission to stream these texts requires that attribution be given and permission noted and that the liturgical use be removed from all sites three weeks after posting the service.

### ***Church Publishing Incorporated books***

Should you wish to read via video or social media a children's book published by CPI, we ask that you contact us at [CPIrights@cpg.org](mailto:CPIrights@cpg.org) to make an official request. Once permission is granted, these guidelines should be followed:

- Teachers, librarians, parish formation staff and clergy who intend to make use of such permission email their name, contact information, and the title and author / illustrator of the books they intend to use to [CPIrights@cpg.org](mailto:CPIrights@cpg.org) to begin the process.

- All posts or videos should include the name of the book or other resource, the author's (and illustrator, where appropriate) name, and mention of Church Publishing Incorporated as the publisher of the material.
- All postings or videos include a note that they are being shared with permission from Church Publishing Incorporated.
- All posts and videos be removed after a period of three weeks.
- Authors and illustrators may read or share their own work, as long as they've received permission from a co-creator. Please inform us when you do this so we can keep track of what is being shared where.
