Automation in traditional RTG stacks is difficult due to the challenge of separating horizontal transportation and stack operation - mainly with regards manned trucking. Finding a way of separating this traffic in a safe manner from the RTG stack operation, as is done in ARMG terminals, will be crucial to a successful automation approach. Electrification often leads to reconsideration of the current port equipment already used and converting from an RTG operation to an ARMG one. Such a conversion would require significant disturbance of the ongoing operation as well as a significant capex due to required civil work and infrastructure investment. When the port developed new post-construction storm water management standards Trapac decided to redevelop the terminal to comply with the port's standards. The project encompassed 65 acres, which included an 11-lane entrance gate and approximately 55 acres of backland redevelopment. The new 11-lane entrance gate was designed and built to convert and expand an existing truck exit gate to an entrance gate. 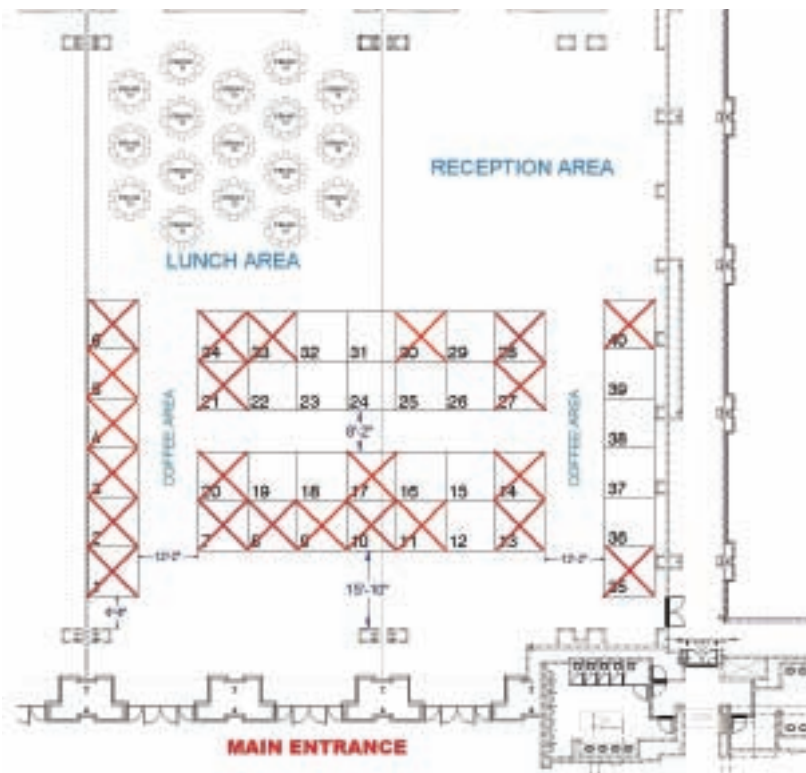
