 - S. 1760, the Public School Civil Rights Act of 1981.
 - S. 1361, Amendment to Title IX of the Education Amendments of 1972 related to sex discrimination.
 - S. 584, A bill to amend section 1979 of the Revised Statutes (42 U.S.C. 1983), relating to civil actions for the deprivation of rights, to limit the applicability of that statute to laws relating to equal rights.
 - S.J. Res. 41, A joint resolution proposing an amendment to the Constitution of the United States relating to affirmative action.
 - S.J. Res. 17, A joint resolution proposing an amendment to the Constitution of the United States for the protection of unborn children and for other purposes.
 - S. Con. Res. 101, A concurrent resolution to provide that a handicapped child's right to life should not be abridged or denied on account of age, health, defect, or condition of dependency.
 - S. 2930, Migrant and Seasonal Agricultural Worker Protection Act.
