Are you a child welfare expert, attorney or academic? Are you part of an organization that utilizes the Illinois CASA/GAL network? Do you design, develop, or implement juvenile justice solutions? Do you study and measure juvenile abuse and neglect cases? The 2020 Illinois CASA State Conference needs you!

You are invited to submit a proposal to share your experience and expertise with our statewide network of specially trained volunteer advocates and staff from 32 local CASA programs at the 2020 Illinois CASA State Conference. This year's theme: *Change a Child's Story™* will promote the importance of collaboration to affect change. We hope the experience will be educational, informative, inspirational and entertaining for our presenters and guests.

The conference attracts about 400 attendees, many of whom have direct responsibility for and decision-making authority over the provision of child advocacy services, solutions and practices. Year after year, it draws a loyal following of participants eager to learn about – and be able to implement – the latest ideas, best practices and relevant approaches in advocacy for children who have experienced abuse and neglect.

Presentation proposals are welcome on any topic relevant to CASA. The conference will feature both individual presentations and panel discussions. Topics of particular interest include:

- Human Trafficking, Domestic Violence, Addiction and Drug Trends in Illinois
- Trauma Informed Services, Foster Parent Recruitment
- Diversity, Inclusion, Implicit Bias, LGBTQ, Poverty
- Secondary Trauma, Volunteer Safety, Quality Advocacy
- Public Policy, Family First Act
- Community Engagement, Volunteer Recruitment and Social Media

Presentation timeslots will be 90 minutes and will be strictly regulated to ensure the conference runs according to schedule. All sessions must include time for audience questions and comments.

Presentation materials will be archived and made available to attendees. At the discretion of the presenter, materials may be made available to the public on the Illinois CASA website.

Please note that product demonstrations are **not** acceptable conference presentations. Individuals and organizations who wish to "showcase" sites or products will have an opportunity to do so at the Forum venue but not as part of their presentation.
