Dear Mayor Jordan,

As discussed in our previous meetings, I am providing you with an update on the staffing reallocation plan and the associated data for the first due area of Station 835 (Greenbelt Volunteer Fire Department and Rescue Squad, Inc.).

Although the Prince George's County Fire/EMS Department remains critically short-staffed, we continue to implement overtime mitigation strategies accordingly, monitor response times and service delivery, and address any identified resource gaps. Recent resource reallocations in the Greenbelt area include the following:

- Beginning on October 13, 2024, the Fire/EMS Department committed to utilizing system status management to deploy fire suppression resources into the Berwyn Heights area as needed. Between Sunday, October 13, 2024, through January 25, 2025, the Berwyn Heights Volunteer Fire Department and Rescue Squad, Inc. has requested County fire suppression crews a total of 37 times.
- On December 18, 2024, a surge engine was placed at Station 814 on Mondays, Wednesdays, and Fridays (staffed with overtime personnel for 12 hours daily).
- Effective December 29, 2024, the following EMS resources were allocated to Station 835 to support the Greenbelt, Berwyn Heights, College Park, Glenn Dale, Lanham, and Seabrook areas:
 - Paramedic Ambulance 858 (staffed 24/7 with overtime personnel)
 - Ambulance 899 (staffed with overtime personnel from 0700-2300 hours)
 - Northern EMS Duty Officer (staffed 24/7 with non-overtime personnel)

One of the main concerns with the staffing reallocations was that the response times to emergencies would be impacted. We have done an extensive analysis of calls that took place between June 30, 2023, through January 25, 2024, and June 30, 2024 through January 25, 2025, which is detailed in the table below:

We have conducted an analysis of stations that were dispatched to Station 835's first due area between the designated timeframes (June 30, 2023, through January 25, 2024, and June 30, 2024, through January 25, 2025), which is detailed in the table below:
