

A Resolution for Conservative Leadership in the Texas House

BE IT RESOLVED, The Tarrant County Republican Party calls for every Texas Republican Legislator to publicly support the RPT Platform plank number 233 banning the appointment of Democrat committee chairs. We call for the Lt. Governor and the Speaker of the House to only appoint Republicans to Committee Chair positions.

BE IT FURTHER RESOLVED, that any speaker candidate announcing the support of Democrat members of the legislature prior to a caucus meeting is a violation of Plank 233, which is also designed to end the ability for Democrats to pick a speaker.

BE IT FURTHER RESOLVED, a vote for any speaker candidate who vocally supports the appointment of Democrat chairs is also a violation of Plank 233.

BE IT FURTHER RESOLVED, this resolution shall be sent to all Republican State Legislators, the Speaker of the House and The Lt. Governor.

A Resolution to Protect the Citizens of Tarrant County and the Sovereign State of Texas

WHEREAS, the health, safety, and welfare of Tarrant County residents and other Texas Counties are under an imminent threat of disaster from the unprecedented levels of illegal immigration, human trafficking, and drug smuggling coming across the U.S. border from Mexico; and

WHEREAS, according to the U.S. Department of Health & Human Services (HHS), Tarrant and surrounding counties have absorbed thousands of unaccompanied minors placing an even further strain on public schools and taxpayers of Tarrant County; and

WHEREAS, Tarrant County law enforcement has seized enough fentanyl to kill over 400,000 residents³; and

WHEREAS, since January 2021, more than 3.6 million illegal aliens have been apprehended after unlawfully entering the United States; and

WHEREAS, unaccompanied minors have been lost, exploited, raped, molested, and released to unvetted sponsors due to the failures of the Biden Administration & Alejandro Nicholas Mayorkas and are trafficked on Texas soil; and

WHEREAS, the unprecedented ongoing immigration crisis continues to wreak havoc on the sovereign state of Texas facilitated by criminal cartel organizations operating in Mexico and Texas and encouraged by the Biden Administration; now, therefore, be it

RESOLVED, the Tarrant County Republican Party recognizes that extraordinary and unprecedented measures must be taken to ensure the protection of the health, safety, and welfare of Tarrant County residents, fellow Texas counties and innocent exploited children; and further

RESOLVED, the Tarrant County Republican Party fully encourages and supports the Governor of Texas to take necessary steps as allowed under Article I, Section 10, Clause 3 of the United States Constitution and Article IV, Section 7 of the Texas Constitution to secure the Texas border and stop the invasion at our sovereign border.

RESOLUTION TO DIRECT FUNDING OF THE TEXAS STATE GUARD

Whereas the State of Texas currently maintains a significant budget surplus;

Whereas the Governor of the State of Texas declared an Invasion pursuant to Article IV, Section 7 of the Constitution of the State of Texas on July 7, 2022 and reiterated November 16th, 2022;

Whereas the Governor maintains sole authority over the Texas State Guard, pursuant to Chapter 437 of the Texas Government Code; and

Whereas the current Texas State Guard troop levels are inadequate to maintain full-spectrum operations in the current state of invasion on the Texas/Mexico border; now, therefore, be it

Resolved, that the Tarrant County Republican Party urges the legislature of the State of Texas, in cooperation with the Commander-in-Chief of the Texas State Guard, Governor Gregory Wayne Abbott, appropriate from current budget surpluses sufficient funds to mobilize and equip such forces necessary to secure the Texas/Mexico border, construct a wall, end the invasion and establish and maintain a state of peace in the State of Texas.

Be it further Resolved this resolution shall be sent to the Governor and all members of the Texas Legislature.

RESOLUTION TO SUPPORT THE COMMANDER-IN-CHIEF OF THE MILITARY FORCES OF THE STATE OF TEXAS

Whereas Article IV, Section 7 of the Texas Constitution states “GOVERNOR AS COMMANDER-IN-CHIEF OF MILITARY FORCES. He shall be Commander-in-Chief of the military forces of the State, except when they are called into actual service of the United States. He shall have power to call forth the militia to execute the laws of the State, to suppress insurrections, and to repel invasions.”;

Whereas Governor Gregory Wayne Abbott invoked Article IV, Section 7 of the Texas Constitution on July 7, 2022 and reiterated on November 16, 2022 declaring an invasion of the State of Texas; and

Whereas the federal government of the United States has abrogated the responsibility to protect the states that form the Union, and Texas specifically, from an invasion of foreign nationals that pose a clear and present danger to the life and property of the citizens of the State of Texas; now, therefore, be it

Resolved, that the Tarrant County Republican Party calls for, without delay, the Governor of the State of Texas, in his capacity as Commander-in-Chief of the Texas Military Department and of the Texas State Guard under the authority of Title 32 of the U.S. Code and Chapter 437 of the Texas Government Code, to proceed with due expedience to call forth the Texas State Guard and direct them to secure the Texas/Mexico border. Forces mustered, including a general enlistment of volunteers for the Texas State Guard, under the sole command of the Governor of the State of Texas, must be adequately armed and directed to use such force necessary to achieve this objective.

Be it further Resolved this resolution shall be sent to the Governor and all members of the Texas Legislature.
