### GET HELP APPLYING FOR ASSISTANCE

WHEAP helps eligible households with their heating and electric bills. If the gross income for your household is less than the amount shown at right, you may be eligible. WHEAP staff will be on hand at both events to answer your questions and help you apply.

### INFORMATION YOU WILL NEED

Make sure to collect and bring the following items before applying for your benefits:

- **For you and everyone else living in your household:**
  - ☐ Date of birth and Social Security Number (or government issued ID number)
  - ☐ Proof of income (see list of needed items at right)
- **The types of energy that you use:**
  - ☐ Fuel type(s) - Electric, natural gas, oil, propane, etc.
  - ☐ Name of utility that provides your power
  - ☐ Account number (as shown on your bill) for each utility company you have
- **Your landlord or property management company information** (if applicable).
  - ☐ Landlord first and last name or full company name
  - ☐ Address and phone number
  - ☐ Copy of lease, if heat or electricity is included in rent

### PROOF OF INCOME

Bring copies of the following documents:

- Proof of income received for previous month for all household members
  - For November event: check stubs with pay dates in October
  - For December event: check stubs with pay dates in November
- Bank statement for Social Security, Veterans Benefits, Pension, Disability or SSI. A benefit/award letter will also work for Social Security
- 1099 form for any interest, dividends, IRAs, or annuities
- Income tax forms for self-employment, farming or rental income
