Re: Precertification requirement for certain gastroenterology procedures for most Cigna commercial customers, effective January 1, 2022

Dear MOUNT SINAI HEALTH SYSTEM,

Effective January 1, 2022, precertification for the gastroenterology procedures listed below will be included in the list of outpatient services requiring precertification for most Cigna commercial (non-Medicare) customers whose plan requires outpatient precertification.

- Esophagoscopy/Esophagogastroduodenoscopy (EGD)
- Most capsule endoscopies

Our goal is to help ensure that these tests and procedures are medically necessary according to evidence-based guidelines. We have delegated precertification of these procedures to eviCore healthcare (eviCore). eviCore's specially trained nurses and gastroenterologists will use evidence-based guidelines to determine medical necessity.

At a glance

- Effective January 1, 2022, the gastroenterology procedures listed below will require precertification for most Cigna commercial (non-Medicare) customers.
 - Esophagoscopy/Esophagogastroduodenoscopy
 - Most capsule endoscopies
- Our goal is to help ensure that these tests and procedures are medically necessary according to evidence-based guidelines.
- You must request precertification for these procedures directly through eviCore healthcare.

Precertification process

eviCore will begin taking precertification requests on January 1, 2022.*

The preferred and most efficient method for submitting precertification requests is through eviCore's website (eviCore.com). If you are not a registered user, you can go to eviCore.com > Register Now.

While we encourage you to submit requests through the website, you can also request precertification by calling eviCore at **866.668.9250** (7:00 a.m. to 7:00 p.m. local time).
