Sojourner House is seeking an experienced full-time CLINICAL SUPERVISOR to lead and oversee the day-to-day services and functioning of the Sojourner House treatment program and provide clinical support to Sojourner House MOMS HUD residential permanent housing programs with behavioral health disorders, ensuring overall quality and excellence. Responsible for the facilitation and supervision of all clinical functions; staff development, training, and supervision; outcomes; referral relationships and marketing; licensure, regulations and credentialing; quality assurance; and the general oversight of facility maintenance.

REQUIRES:

- Master's degree or above from an accredited college in Social Work, Psychology, Counseling, Chemical Dependency, Nursing (with a clinical specialty in administration or human services), or related field required, Full certification as an addictions counselor, such as LSW, LCSW, LPC and/or supervisory experience preferred. (BS degree may be considered with at least 3 years of clinical supervisory experience.)
- 2 years of supervisory experience or completion of a core curriculum in clinical supervision.
- At least 2 years of clinical experience in a health or human service agency which includes 1 year of working directly with the chemically dependent.
- Experience working in an in-patient residential treatment program preferred.
- Current/valid Driver's License and ability to drive a 12 passenger van as needed to escort residents within the East End and surrounding communities.
- Understanding of dynamics of mental health, substance abuse, maternal addiction, and recovery methods.
- Demonstrated successful ability to hire, coach, train, and develop staff; and create a positive team-oriented educational, work environment.
- Advanced interpersonal, written, and verbal communication skills to establish and maintain good will and good working relationships with staff, clients, family members, other service providers, volunteers, board members, and community representatives.
- Excellent time management skills.
- Ability to conduct individual, family, and group counseling sessions.
- Knowledge of community resources, e.g., DPW, food banks, and family education/recreation.
- Cultural sensitivity and the ability to maintain professional level confidentiality.
- Full-time salaried position, Monday – Friday, 8:30am – 4:30pm, plus on-call and flexibility/open availability a must

SPECIAL CRITERIA

- Because of program treatment philosophy, person identified with – or who have been diagnosed with – an alcohol or other drug dependence must be abstinent for at least two years prior to employment and remain abstinent throughout employment. All candidates must be willing to adhere to the Substance Abuse/Drug Free Workplace policy including pre-employment screening.
- Ability to acquire Act 33/34 & FBI clearances (employer reimbursed – after contingent job offer.)
- Must obtain annual TB (PPD) testing (employer reimbursed – after hire.)
- Must attend and participate in all required training (after hire.)
