Driving Diversity, Equity, and Inclusion: Creating An Energy STEM Initiative

April 28, 2021 – 9:00 AM to 1:00 PM

PURPOSE

Is it possible to graduate 25,000 students of diverse backgrounds representative of California's diverse populations?

The California Public Utilities Commission and Hispanics In Energy are convening a group of influential stakeholders and key thought leaders to ponder that question. Can California prepare and produce 25,000 energy STEM graduates by 2025 and sustain that for a generation?

There are promising approaches to creating a diverse pool of Black, Native American, and Latinx students to excel in energy sector STEM jobs. Underlying obstacles will have to be managed effectively by those in a position to make a difference.

Framing questions: How can California create and support an educational pathway for an energy STEM career? What are the tasks to attain 25,000 graduates of diverse students per year by 2025? We will encourage collaboration between stakeholder representatives from industry, government, academia, and community organizations to diversify the energy sector's STEM job.
