On November 14th the AHCA NCAL State Affiliate meeting met and discussed the following agenda:

COVID has been hard on the long-term care profession in many, many ways, not the least of which is the erosion of trust of the long-term care staff in our professional leaders. There was also open discussion on multiple vital issues to this profession. The State Affiliate representatives meet virtually monthly, so if you have issues that you want raised at the National level, please, let the Association know.

As we transition from Thanksgiving to Christmas, it would probably be advisable to review the life safety "rules" for decorations. First, decorating for the holidays is fun for the residents and the staff, along with visitors and it is a way for reminiscence and community involvement. The holidays should be uplifting for both residents and staff. Here are a few hints and tips related to the life safety code:

- Combustible decorations are only permitted if they are flame retardant OR when are in limited
 quantities such that the hazard of fire development and spread is not present, such as a handful
 of holiday cards attached to a door. A door completely covered with holiday cards would be
 considered excessive. "Any combustible decorations hung from doors or walls in corridors may
 be used with a waiver. Non-rated combustible decorations cannot exceed 20% of wall space in
 an exit egress corridor."
- Live Christmas trees are not permitted.
- Artificial Christmas tress are only permitted if they are labeled or identified as "flame retardant" or "flame resistive". It would be advisable to keep the box the tree came in accessible to prove the "flame retardant" condition, if requested. There are products that can be applied to artificial tress to meet this requirement, but documentation of date and product should be kept on hand.
- Use only UL listed holiday lights and wiring.
- Do not visually block egress, exit signage or any fire safety equipment with decorations, including fire alarm pull stations, visual fire alarm notification devices and fire extinguishers.

- Do not hang decorations from sprinkler heads.
- Do not use flame-producing decorations including candles.
- Do not use extension cords to power decorations.
- "Any combustible decorations hung from doors or walls in corridors may be used with a waiver.
 Non-rated combustible decorations cannot exceed 20% of wall space in an exit egress corridor."
- Safe decorations include:
 - Artificial Christmas trees and decorations that are non-combustible or flame retardant
 - o UL approved decorative lights used in supervised areas and turned off when not in use
 - UL approved outdoor lighting
 - Holiday decorations, including evergreen wreaths, ornaments, photos, etc can be used on residents' doors and in hallways, as long as they do not exceed 3-1/2 inches in depth and they are not blocking the entrances or exits
 - Battery-operated flameless candles
