

#### May, 2022 Reflections

On April 7, 2022, CMS issued QAO-22-15-NH & NLTC & LSC updating COVID-19 Emergency Declaration Blanket Waivers for Specific Providers. First, applicable waivers will remain in effect for hospitals and critical access hospitals. That means that the 3-day hospital waiver remains in effect for the foreseeable future. The waivers will end 30 days after publication (April 7, 2022) for the following, meaning all of these activities should be resumed by this time:

•

- In-person resident group meetings should be resumed
- Physicians that delegated tasks to a physician assistant, nurse practitioner or clinical nurse specialist must resume those tasks in person
- All required physician visits must be made by the physician personally rather than delegating to a nurse practitioner, physician assistant or clinical nurse specialist
- Physician and non-physician practitioners must perform in-person visits for nursing home residents & no longer conducted via telehealth options
- Facilities are now required to follow all QAPI regulations including to develop, implement, evaluate and maintain an effective, comprehensive, data-driven QAPI program
- Facilities are now required assist residents and their representatives in selecting a post-acute care provider using data, such as standardized assessment data, quality measures and resource use
- Facilities must again provide a resident a copy of the resident's records within two (2) working days when requested by the facility or representative

Waivers that will end 60 days after April 7, 2022 (June 6) include:

- A non-SNF building may no longer be certified and available for use by a SNF in the event there were needs for isolation processes for COVID-19 positive residents with State approval
- All facility and medical equipment inspection, testing and maintenance must be completed as required by life safety requirements
- · Paid Feeding Assistants must again complete all requirements for training
- In-Service training for nurse aide requirements including 12 hours of in-service training annually must be completed
- All nurse aides, including those hired under the blanket waiver must complete a state-approved Nurse Aide
  Competency Evaluation Program (NATCEP) to become a CNA and NAII's may not work for a facility for longer
  than four (4) months unless they met the training and certification requirements. This requirement eliminates
  the use of Temporary Nurse Aides (TNAs) 120 days after the waiver is lifted if the state allowed TNAs.
