### ANNOUNCEMENTS- 2 NEW GRANT OPPORTUNITIES FOR SARPC'S PLANNING DEPARTMENT!

#### 1. EPA BROWNFIELD ASSESSMENT GRANT

SARPC was recently awarded a \$500,000 grant from the Environmental Protection Agency (EPA) for a Brownfields Assessment project. SARPC planners will work with PPM Consultants over the next 4 years on this project that targets areas along Highway 43 near Creola and Highway 31 near Atmore. PPM will conduct the assessments to determine if abandoned Brownfield properties in these areas are contaminated, with the end goal being identifying sites can be redeveloped and marketed to recruit new economic development opportunities to these communities.



- WHAT IS THE BROWNFIELD PROGRAM?

The purpose of SARPC's BROWNFIELD PROGRAM is to help redevelop abandoned, idle, or under-utilized properties where expansion or redevelopment is hindered by actual or perceived environmental conditions. The program provides no-cost environmental services offered by SARPC designed to facilitate the development of any commercial property, whether a private or public transaction to help spur economic growth throughout our Region. This funding opportunity is available to SARPC each year through the EPA.

- WHAT DOES THE BROWNFIELD PROGRAM PAY FOR?

Grant funds can be used to pay for environmental assessments and other upfront environmental planning costs to help move commercial properties towards redevelopment. Services such as Phase I and Phase II Environmental Site Assessments (ESAs), asbestos inspections, underground storage tank removals (when eligible), and cleanup planning/cost estimating are among some of the no-cost services that can be provided for public, private, or non-profit entities on both public and privately owned properties. SARPC can provide these services for eligible sites/entities,

minimizing upfront costs that can be put towards better use in the actual development and/or redevelopment of a commercial property.

- **WHAT ARE THE BENEFITS OF THE BROWNFIELD PROGRAM?**

- ✓ Will make property more attractive by identifying potential concerns regarding the environmental condition of the property.
- ✓ Will cover the costs of environmental studies, reducing capital expenditures associated with All Appropriate Inquiries (AAI) prior to purchasing and redeveloping a commercial property.

- **WHO CAN APPLY FOR THE BROWNFIELD PROGRAM?**

Any commercial property within SARPC's jurisdiction (Mobile, Baldwin, and Escambia Counties) is eligible for funding, regardless of ownership.

### **WHAT IS THE BROWNFIELD PROGRAM?**

The purpose of the program is to help redevelop abandoned, idle, or under-utilized properties where expansion or redevelopment is hindered by actual or perceived environmental conditions. Examples include abandoned gas stations, industrial, and commercial properties. Grant funds can be used to pay for environmental assessments and cleanup planning to help move commercial properties towards redevelopment.

SARPC was recently awarded a \$500,000 Community-wide Assessment Grant from the United States Environmental Protection Agency. PPM Consultants, Inc. has been retained by SARPC to facilitate the grant program and to get the word out to the commercial real estate community and to potential buyers and sellers of real estate.



### **WHAT DOES THE PROGRAM PAY FOR?**

- **Phase I Environmental Site Assessments (ESAs):** Like title searches, surveys, and appraisals, such assessments are now routine on commercial real estate transactions. Phase I ESAs include a site inspection, interviews with persons knowledgeable about the history of the property, and a review of environmental records to determine if any Recognized Environmental Conditions (RECs) exist.
- **Phase II ESAs:** If the Phase I ESA identifies any RECs, additional investigation may be needed to determine if adverse environmental conditions actually exist. Phase II ESAs may include soil, surface water, and groundwater testing; asbestos surveys; lead-based paint surveys; mold surveys; tank removal; and/or threatened and endangered species studies.
- **Cleanup Planning:** If a site is found to be impacted, the grant will pay for certain engineering and consulting fees to plan for redevelopment. This can include remedial alternatives analysis and meeting with regulatory agencies.



## WHAT ARE THE BENEFITS?

- Will make your property more attractive by identifying potential concerns regarding the environmental condition of your property.
- Will cover the costs of environmental studies, thus reducing capital expenditures associated with All Appropriate Inquiries (AAI) prior to purchasing and redeveloping a commercial property.
- No contractual obligations to SARPC or consulting firm providing the studies.

## WHAT SITES ARE ELIGIBLE?

Any commercial property within SARPC's jurisdiction (Mobile, Baldwin, and Escambia Counties) is eligible for funding, regardless of ownership. The program is designed to facilitate the development of any commercial property, whether a private or public transaction.

## 2. DELTA REGIONAL AUTHORITY (DRA) GRANT SUPPORT PROGRAM

SARPC was recently awarded a grant from the Delta Regional Authority (DRA) to fund a “Grants Support Specialist” position in the Community Development Department.

SARPC serves as the DRA’s Local Development District (LDD), and this new funding opportunity is available to all LDD’s who wish to apply. Due to the increase in federal funding from the American Rescue Plan, Bipartisan Infrastructure Law, Inflation Reduction Act, etc., this program has been designed as a capacity-building program for all of the DRA’s LDDs by providing the needed resources to fill capacity gaps and





undertake the additional workload associated with grant administration responsibilities. The goal of the program is to bolster access to DRA resources for economically distressed communities.

These funds will enable SARPC to provide a grants specialist who will work with SARPC's member governments and partners in Escambia County (DRA funds are only eligible in Escambia County) to identify potential economic development projects in each community, and to help apply for and manage the grants. This is an ideal and optimal opportunity for SARPC and will enable our Commission to expand our grant writing and management services to our member governments.

#### DELTA REGIONAL AUTHORITY (DRA)

- **Critical Infrastructure Fund (CIF)** (Escambia County only)-Grant cycle opened in March for critical infrastructure projects and business and workforce development projects. There is no deadline to apply for this fund. Visit: <https://dra.gov/> for more information.
- **DRA Strategic Planning Program** (Escambia County only)- This program offers funding for planning projects in Escambia County. This grant has a continuous, revolving cycle, so there is no deadline. Funds can be used to cover, but not limited to the following types of plans:

  - Master Plans
  - Capital Improvement Plans
  - Workforce Development Plans
  - Preliminary Engineering Reports
  - Transportation Plans
  - Broadband Deployment Plans

#### ECONOMIC DEVELOPMENT ADMINISTRATION (EDA)

- **Public Works and Economic Adjustment Assistance (PWEAA)** Notice of Funding Opportunity (NOFO). The FY23 PWEAA NOFO outlines application submission requirements and review procedures for applications received under EDA's Public Works and Economic Adjustment Assistance (EAA) programs.

The Public Works program provides resources to meet the construction and/or infrastructure design needs of communities to enable them to become more economically competitive.

Supported activities under EDA's EAA program include construction and non-construction such as construction or upgrading of public infrastructure, sectoral partnerships for workforce training, design and engineering, technical assistance, economic recovery strategies, and capitalization or re-capitalization of Revolving Loan Funds (RLF).

There are no application submission deadlines and applications will be accepted on an ongoing basis.

### SOUTHEAST CRESCENT REGIONAL COMMISSION (SCRC) (MOBILE AND BALDWIN COUNTIES ONLY)

*The Southeast Crescent Regional Commission (SCRC) is a federal-state partnership authorized in the 2008 Farm Bill to promote and encourage economic development in areas of Alabama, Georgia, Mississippi, North Carolina, South Carolina, Virginia, and all of Florida. SCRC invests in projects that support basic infrastructure, business development, natural resources, and workforce/labor development. SCRC's mission is to help create jobs, build communities, and improve the lives of those who reside in the 428 counties of the seven-state region.*

After 18 months of existence, the Southeast Crescent Regional Commission has released a Notice of Funding Availability (NOFA) outlining the inaugural State Economic and Infrastructure Development (SEID) grant program. ### ADECA's LAND & WATER CONSERVATION FUNDING (LWCF)

The Alabama Department of Economic and Community Affairs (ADECA) will announce their funding opportunity in August for the Land & Water Conservation Fund. This grant opportunity provides funding for virtually all public outdoor recreation activities. These projects are eligible for assistance through the program to include playgrounds, ball fields (including lighting with metal or concrete poles only), court sports, picnic areas, camping areas, trails, swimming facilities and splash pads, etc. In addition, outdoor recreational support facilities such as concession stands, restrooms, press boxes, park access roads, parking areas, utilities, and site preparation necessary to make a recreation activity area usable may qualify for assistance.

The LWCF program provides 50 percent matching assistance to project sponsors. The project sponsor may provide the remaining 50 percent of the project costs in the form of cash and/or in-kind/donated materials and/or services. Grant funds are distributed to project sponsors on a cost-reimbursable basis.

(ADECA) Federal Initiatives and Recreation Division will be hosting the FY 2024 LWCF Grant Application Workshop on Wednesday, August 30, at 1:00 p.m. - 4:00 p.m. in Montgomery. This will be an “in person” workshop only and space is limited. Please contact the Community Development Department if you’re interested in applying for these funds.



### [Smart Growth America Announces Community Connectors Grant Program](#)

Smart Growth America’s new Community Connectors grant program will help advance locally-driven projects to reconnect communities separated or harmed by divisive transportation infrastructure and access available federal and state funds to support these projects. Fifteen teams (e.g., public agencies partnered with nonprofits or other community organizations) from communities with populations of 50,000-500,000 will receive a capacity-building grant of up to \$130,000 in addition to tailored training. ### [USDA Rural Energy Programs](#)

The US Department of Agriculture (USDA) announced the availability of nearly \$11 billion in grants and loan opportunities to help rural energy and utility providers bring affordable clean energy to communities. Funding will be available through two new programs under the Inflation Reduction Act: **Empowering Rural America (New ERA) program and the Powering Affordable Clean Energy (PACE) program**. USDA will accept Letters of Interest from June 30 to September 29 for the PACE program and from July 31 to August 31 for the New ERA program.
