## Pastor's Annual Report 2024

I am generally a person who seeks to look ahead and to think of possibilities moving forward. Some years it is hard to look back and others it is easier. Thinking about and reflecting on 2024 is an easy year to consider. St John United Church of Christ – Appleton has had a good year.

I want to celebrate with you all how our worship has grown. Maybe it has not grown in numbers but in devotion we have. More folks are willing to share in worship leadership and for that I am grateful. Others have stepped up to serve communion and that helps lead us in the Body of Christ. ## Wisconsin Conference UCC Year 2024 in Review

***“Arise, shine; for your light has come, and the glory of the Lord has risen upon you. Then you shall see and be radiant; your heart shall thrill and rejoice.” Isaiah 60: 1 and 5***

I write this year-end Wisconsin Conference UCC summary on Epiphany Day and send it with prayers of light and love to you and your congregation. This day happens to coincide with the certification of Electoral College votes and the formal election of the next president of the United States. Four years ago, our Capitol was under siege by people seeking to undermine a free and fair election. This year we pray that the peace of Epiphany will abide. Inauguration Day, Jan. 20, this year coincides with the holiday commemorating the life and work of the Rev. Dr. Martin Luther King Jr. In true UCC spirit, I invite you to pray for the dignity, equality and basic human rights of all who are marginalized or poor or feel unwelcome in this country.

The Epiphany season is about Christ’s incarnation through the way we embody the teachings of Jesus. The role of the wider United Church of Christ is to resource, equip and support local churches in this vital ministry of incarnation. We do this in myriad ways, from guiding the Search and Call process and facilitating pastoral authorization, care and oversight; to our Damascus Project coursework and the training we offer on “best practices” for the church; to faith formation retreats and the many justice working groups that are eager to support your church’s local efforts.

Sixteen months ago, the Conference Board of Directors and staff met in a retreat setting to begin conversations about the restructuring of our Conference life. Those discussions were an acknowledgment of the challenges inherent in maintaining two midlevel judicatories – the associations and Conference – in a Conference less than half the size of our founding membership in 1962. We wondered if unburdening ourselves of the many committee slots in the current structure might allow us to redeploy volunteer time and talent according to people’s passions.

Throughout our conversations with stakeholders two ideas stood out like bright epiphanies – first, our desire to nurture UCC relationships beyond the local church, and second, our desire to collaborate in the sharing of ministry ideas and resources. This reframed the question about structural change from *What are we letting go of?* to *What are we living into?* Last fall, after several listening sessions and in consultation with Association leaders, the Board and staff recommended that we dissolve our four Associations at the Wisconsin Conference Annual Meeting in June. We have scheduled


additional conversations in each Association in late February and early March for the purpose of sharing more details and illustrating the ways in which we might connect and support one another for greater ministry impact.

So far, we have nearly completed the proposal for a unified Committee on Ministry with regional representation. We appreciated the generous mission and scholarship support provided by the Associations and have made provisions for continuing them. We have drafted a new framework for membership dues and are preparing to streamline Association finance ledgers. And we have created a graphic that explains the Conference-wide resource web by showing the connections among our many resource hubs and active working groups. Imagine all the innovative ideas that will surface!

I feel the heart of this beloved Conference rejoicing at the advances we made in 2024:

- We launched a new website. Check it out at [wcucc.org](http://wcucc.org).
- We offered several marketing resources around the theme “Where God Is Still Speaking.”
- We made progress on the Leadership Forward campaign, with more than \$1.1 million pledged.
- We expanded Damascus Project course offerings and added an online Confirmation program.
- We created a volunteer Legacy Team that will accompany churches in closing decisions.
- We challenged our congregations to surface 20 new potential pastors over two years.
- We continued to strengthen our partnership with United Church Camps Inc.
- We advanced our anti-racism training through a course taken by Board and staff in the fall.

## MISSION SERVICE 2024 Annual Report

We resumed our monthly meetings after taking January and February off due to difficult weather conditions. We sponsored the "Help the Homeless" Hygiene Drive from February to March by having a collection box placed at the Tauber Center. Thank you to all who participated to help our community. We also provided funds for the Upper Room Devotional books. A monetary donation of \$50 was made to each of the speakers' programs. We did not convene in January and February.  
Our monthly meetings were:

**March:** Janal Emmer of SOS Project Fox Valley provided information about the financial needs of people in crisis due to illness, accidents or fires and her plans to be of assistance. We are sponsoring the Help the Homeless Box again this year and will focus on St. Joseph's Food Program for the next several months.

**April:** Jeannie Micke from Heads Up Fox Cities talked about her work with high school students who are homeless after they turn 18 and age out of foster care. A box was placed at Tauber Center for donations.

**May:** Heather DuVall from St. Joseph's Food program discussed the current program and the Capital Campaign for a needed expansion. 8 members of the congregation attended The Altrusa Sponsored NAMI Luncheon as gold sponsors/donators (\$750).

**June:** Julie Bargholtz and Holly Hayes from the Appleton School District discussed the school lunch program \$ deficits. The program covers 15 Appleton Public Schools (elementary -high school). Also discussed varies closets, need for donations, and volunteer opportunities. 7# of goods taken to St. Joe's and donations also taken to Heads UP program.

**July:** Holly Keegan introduced us to her program; "Make A Ride Happen". The program provides transportation to individuals for appointments. She coordinates with the volunteers who supply their vehicle. 36# of groceries taken to St. Joe's Food Pantry.

**August:** We had the annual picnic hosted at Karen & David Kuhn's residence. Beautiful day with lots of conversation and smiles. We enjoyed a tour of the orchard, garden and bee hives.

**September:** The Speaker couldn't attend due to illness. Decided to start filling "Blessing Bags" on Sept. 15 service and Jeanne Senner will continue to coordinate.

**October:** The Boys and Girls Club of the Fox Cities, represented by Marissa and Melissa, who are Directors, discussed the programs. The organization is involved

in the various school systems throughout the valley in after school activities and summer school. Deliveries of collected products to St. Joe's and Heads Up. Several members were involved in the annual NAMI Walk.

**November:** Speaker was unable to attend. Meeting cancelled.

**December:** A Christmas gathering was well attended @ the Black Bear Restaurant and we enjoyed good fellowship and food.

### SCRIP 2024 Annual Report

We thought we would share a few FYIs about SCRIP:

- SCRIP cards are easy for everyday use, like gas and groceries!
- There are hundreds of businesses available through SCRIP. If you are curious about what businesses are available, you can check with us, or check out <https://www.raiseright.com/brands>
- Each business provides a different percentage discount on the cards we purchase, anywhere from 1.5% up to 10%, and sometimes even more!
- We purchase the cards at the discounted rate, but sell them to you at the face value that is used towards your purchase at that business. That is how we make a profit to help the church with bills or special donations.
- There are some local businesses not in RaiseRight that we get through another church partner. If you have questions on those available local businesses, please ask!
- SCRIP cards are safer than using your personal credit card online or even in stores, as no personal information is attached to that card. BUT you should treat your SCRIP card like cash, because if you lose it, it is gone.
- We try to order the first Sunday of every month from RaiseRight, our SCRIP card provider. There is a shipping charge applied to our order, so we try to have a large order to offset the shipping costs, so our profits aren't eaten up by the shipping cost.
- If you have any large or special requests, please keep in mind the best time to ask for it is always before you need it, and hopefully before the first Sunday of the month.
- We try to keep the most requested cards in stock. If you have a business you visit often that we don't carry, please ask!
- SCRIP cards make great gifts!!!
