The following Board and Commissions have vacancies and are currently soliciting applications:

Odenton Town Center Advisory Committee

The Odenton Town Center Advisory Committee currently has two vacancies and County Executive Pittman invites interested parties to apply. The nine-member Committee is a volunteer advisory committee that works with county officials, development and business interests, and other stakeholders to implement the goals and objectives of the Odenton Town Center Master Plan, which promotes the development of a vibrant, transit-oriented, mixed-use community in western Anne Arundel County. Candidates should be local residents, business owners, or developers in the Odenton community. The committee meets on the last Tuesday of each month at the Odenton Library. Letters of interest should be submitted by January 10, 2020.

Social Services Board

The Department of Social Services Advisory Board is a working board that helps get the word out about what Department of Social Services (DSS) does and fundraises for programs and services that DSS provides. The ideal board member would have an interest in human service or be passionate about healthcare, adoption, foster care or economic benefits. We are looking for members all over the County. The DSS Advisory Board meets on the 3rd Tuesday of each month on Riva Road in Annapolis.

Pension Oversight Commission

The Pension Oversight Commission is vital to providing oversight and non-binding recommendations on any legislative or funding change proposals to the pension system, independent of both the legislative and executive branches of County government, consistent with sections 606-609 in the County Charter. We are looking for 3 members. The nominees' appointments will go before the council for final approval.

Severn River Commission

The Severn River Commission was created in 1984 by the Anne Arundel County Council and the Annapolis City Council to provide advice to these bodies on policies to enhance and protect the natural, historic and scenic quality of the Severn River watershed. It consists of nine voting members and up to five ex-officio non-voting members who meet once a month. Seven of the voting members are appointed by the Anne Arundel County Executive, and two are appointed by the Mayor of Annapolis. Members serve staggered 3-year terms. The Severn River Commission meets at 4 p.m. on the first Thursday of each month in the Severn Room, 4th floor of the Anne Arundel County [Heritage Office Complex](#), 2664 Riva Rd., Annapolis. Public input on matters pertaining to the natural, historic, and scenic qualities of the Severn watershed is permitted at beginning and end of each meeting, input limited to three minutes per speaker. The Commission is particularly interested in hearing on issues related to current or future legislation or government policies. We are looking for 4 members.
