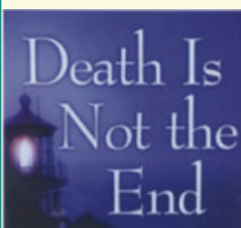
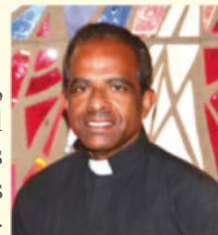

Dear Friends,

**On November 1, we celebrate All Saints' Day, a call to holiness of life. On November 2, we celebrate All Souls' Day, a loving remembrance of our departed loved ones.** On All Saints' Day we celebrate the countless saints, known and unknown to us. The saints serve as models of the numerous ways of being Christ to the world. We turn to them in prayer, as friends, on our spiritual journeys, and we recall them at the Eucharistic table, as those members of the Body of Christ already in God's presence. On All Souls' Day, then, we remember our loved ones who have passed away, pray for their eternal rest, and call to mind that we too will one day pass away. We hope to live, believe, and even die like the holy saints who have gone before us.



**Death is not the end.**

**Death is not reincarnation.**

**Death is not evaporation.**

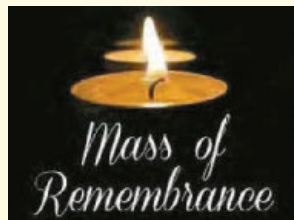
**Death is not annihilation... Death is a trade-in.**

**One day we will trade in our broken-down bodies for a new body.**

Someone once told me as she was preparing for her death, "I Want People to Pray for Me...I want everyone on their knees, begging God to open the gates of Heaven for me. As a child, I asked God to let me have my Purgatory here on earth. I know I am experiencing that suffering to a certain degree. But I also know there is still a lot of work to be done on my soul, so I will likely spend time in Purgatory. But my friends and family can help me on that journey with their prayers. So, when I die, you can celebrate me later. Please first pray for the repose of my soul. Pray that I get to Heaven to be with my Beloved forever."

In fact, we should remember our departed loved ones during the entire month of November. Those who sent in All Souls' envelopes filled in with names, be assured, we will pray for them during our masses in November. There are things we can do in love for departed members of our families.

- ◆ On November 2 or beyond, you can pay a visit to our loved ones in the cemetery.
- ◆ We can offer mass for their soul, and be personally present at the mass. This is a way to have the parish community pray for your loved one.
- ◆ You can place a picture of your loved one on a simple altar at home and light a candle and pray for them as a family.
- ◆ You can pray the Rosary. Rosary is one of the most powerful means available to us - particularly powerful in praying for the dead. Each Hail Mary even ends with asking for grace in death: "pray for us sinners, now and at the hour of our death."
- ◆ Our days are filled with many little trials and sufferings. We can offer these pains for our loved ones. When something happens, we can say something like, "Jesus, I offer You this pain for this person."



**On November 2nd, there is a Mass of Remembrance at St. Stephen at 6:00pm, where the departed loved ones are specially prayed for. On November 5th Sunday at the 10:30am Mass, we have special Mass of Remembrance at CTK campus. You are invited to any of these masses.**

Join us next Sunday, November 5 as we enjoy their beautiful music.



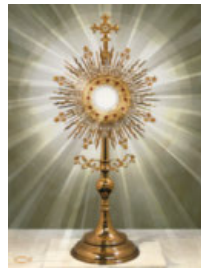

**A blessing will be given to all Veterans represented by a flag, followed by a prayer for those who have gone to their eternal rest. A black ribbon affixed to the flag will signify each deceased Veteran.**

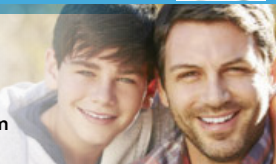
