

#### Dear Beloved Community,

It's hard to believe that we have come to the end of an amazing year of grace and blessing for our community. We became a new entity as we lovingly merged with St. Stephen community. I want to express my deepest gratitude for your unwavering support and commitment to the mission of Christ the King – St. Stephen. We have witnessed God's faithfulness in abundance!



It is a new year, and it is my prayer for all of you — and for me, as well — that we can take new steps on our faith journeys, and seek new ways to live out discipleship and stewardship.

Pope Francis once commented on his perspective of our modern approach to life. He said, "Certainly, possessions, money and power can give a momentary thrill, the illusion of being happy, but they end up possessing us and making us always want more, never satisfied. I would ask you to focus on JOY this year. Christ certainly called us to do that. Pope Francis has had much to say about joy, as well. The Holy Father says, "Joy cannot be held at heel; it must be let go. Joy is a pilgrim virtue. It is a gift that walks — walks on the path of life, that walks with Jesus... proclaiming joy, lengthens and widens that path." We must seek that joy and then we need to share it.


It's easy to get mired down in "what's wrong". It's easy to be unhappy. It's easy to focus on what's hard and what's not going right and what could be better





# Adult Education Mondays, January 8 & January 15 CTK's Ministry Center Chapel 10:30am

Although the Christmas season officially ends with the Epiphany and Ordinary Time begins on January 14th, we will take two sessions to discuss Raymond E. Brown's "An Adult Christ at Christmas: Essays on the Three Biblical

Christmas Stories – Matthew 2 and Luke 2" on January 8th and 15th. Fr. Brown treats the infancy narratives of Matthew and Luke as the entire Gospel story in miniature.



A big thank you to all participants in the ICARE/CORE Food Kit Program!

In two weekends, Christ the King-St. Stephen parishioners donated

\$2500 and 30 volunteers signed up to help.

On Saturday, December 16th, Unity Church of Walnut Creek, our team partner, co-hosted the event at their church and 25 of their congregation joined 25 Christ the King/St. Stephen parishioners to assemble 290 bags of food for the homeless of Contra Costa County. We did it all in 45 minutes with great team work, great enthusiasm and lots of happy smiles! Kids from both churches were present making cards to insert into the bags.

Each kit cost about \$3.35. The total cost was \$1,834. Remaining funds are ear-marked for our next Food Kit Program to be held at Christ the King parish hall sometime in March during the Lenten season.



## End of the Year To Do's Required Minimum Distribution

If you have an IRA, SIMPLE IRA, SEP IRA, or retirement plan account and are over the age of 72 (73 if you reached age 72

after Dec. 31, 2022), you are faced with a required minimum distribution (RMD) by the IRS. Your RMD is the minimum amount you must withdraw from your account each year to avoid significant tax penalties. The IRS has a qualified charitable donation rule that allows you to exempt your distribution from taxes. The significant advantage of this is that it lowers your adjusted gross income. The donation must be paid directly from the plan to the charity and the donor must be over 72. If you are in this situation, check with your tax advisor to see if it makes sense for you to apply this IRS rule and direct your RMD to Christ the King - St. Stephen Parish.




