"TO HEAR THE GOSPEL AND MAKE A DIFFERENCE."

Dear Parishioners:

As you may know, the Diocese of Oakland filed for chapter 11 bankruptcy protection on Monday May 8th. This was expected as our Bishop, Michael Barber, had alerted us to this possibility in March. The bankruptcy filing is in response to the over 330 claims of sexual abuse by clergy in the 60's, 70's and 80's. These claims came about from a state law (AB218) that temporarily removed the statute of limitations on these types of suits to allow decades-old claims that otherwise would be time barred and expired.



The diocese is still quantifying the lawsuits filed but it became clear that the sheer number and amounts claimed would exceed the Diocese ability to satisfy the claims.

As stated in Bishop Barber's letter to parishioners...

"We made the filing because we believe this process is the best way to support a compassionate and equitable outcome for survivors of abuse, while ensuring we continue to provide the essential services and support so crucial to our parishioners and communities."

The bishop's full letter along with other information can be found at ctkph.org. Copies of the letter will be available in the vestibule if you wish to read Bishop Barber's full message.

#### So the obvious question is, what does this mean for Christ the King – St. Stephen Parish?

The bottom line is that this Chapter 11 filing should have no effect on our parish.

First. The scope of the filing is limited to the corporation sole called the Roman Catholic Bishop of Oakland (RCBO). While we are under the RCBO corporate umbrella and within the scope of the filing, our daily operations, ministries, the celebration of sacraments and all other aspects of regular parish life are not affected.

We rely on our parishioners' donations to continue our work and ministries both within our parish and our community. Donations made to Christ the King – St. Stephen parish are dedicated to our parish and restricted to the purpose those donations were made. Donations that are made to the Bishop's Ministries Appeal, are also protected, and restricted to the stated purpose of this appeal. Designated gifts and donations are protected under state law and cannot be used to settle claims. No donations to our parish will be used for any bankruptcy purpose.

Second. While they are part of the Diocese, our school, St. Vincent de Paul, Catholic Charities, and Catholic Cemeteries are under a separate legal corporation and are not included in the Chapter 11 filing. Tuition payments, donations from school families, and donations from our parish to the school are not affected by this filing.

Third. Employment, salaries, and benefits of our employees are not affected. Employees will continue to be paid as usual.

Fourth. The Diocese will continue to administer health and welfare benefits, along with retiree programs, without interruption. Funds for these programs are held in trusts and can only be used for their specified purpose.

Lastly, the bankruptcy process should bring closure to the Diocese and our parishes from all abuse claims. The Diocese is taking responsibility for the damage done and working to provide survivors with some measure of peace and compassion.

Many years ago the Diocese enacted a zero-tolerance policy for sexual abuse, but we must remain vigilant. Please help ensure these terrible acts cannot happen again. Even if you are not an active volunteer or employee, consider taking part in our Virtus Safe Environment training. It is an online, self-paced course on recognizing and acting on suspicions of sexual abuse. It can provide a basis for you to talk with your children about what to look for and to let them know they can tell you anything that concerns them.

This training is required for anyone who serves in any of our ministries, but it is also available to any parishioner. To open the training go to virtusonline.org. If this is your first time, click on first time registrant to get started. If you do complete the training let the office know so we can update your parish record.

Finally, please keep in your prayers the people who have been harmed by sexual abuse, especially those individuals who suffered at the hands of people who were part of our Church.


