



TQHYA Officer Application

Return to TQHA by October 29, 2021

TQHYA is looking for TQHYA members to help with all our youth programs, share their experiences and recommendations for our programs and participate in the growth of our Youth Association. Our Board members can exercise their leadership abilities and learn the responsibility of commitment.

Eligibility:

- All Board members must be twelve (12) years of age and no older than eighteen (18) years of age as of January 1st, 2022.
- All Officers must be fourteen (14) years of age and no older than eighteen (18) years of age as of January 1st, 2022.

Officer Positions and Duties:

- **President:**
The President will have general supervision of the affairs of TQHYA, working with the TQHYA Executive Board, TQHYA Board members and the Youth Activities Committee. The President will preside over all meetings, appoint committees, and submit status reports to all members of TQHYA. Eligibility requires a candidate for President to have served as a TQHYA Officer or TQHYA Board member.
- **Vice-President:**
The Vice-President shall perform duties and exercise the powers of the President in the absence of the President.
- **Secretary:**
The Secretary is responsible for recording minutes at all TQHYA meetings, correspond on behalf of TQHYA and communicate with TQHYA members through the TQHA office.
- **Treasurer:**
The Treasurer shall work with Youth Advisor to coordinate all receipts and expenditures to fund-raising and donations. Treasurer will make a financial report to the TQHYA meetings.
- **Reporter:**
The Reporter is responsible for reporting any TQHYA activities to the media including The Quarter Horse Journal. The Reporter is also responsible for preparing and presenting the TQHYA Scrapbook at AQHYA World Championship Show.
- **Board Member:**
Our Board Members are an essential part of our organization. They will be asked for input and advise from the Executive Committee. Board Members will also be asked to participate in meetings and vote on all issues.
