



“Finding home in the Foreign: Otherness in Immigration”

Julia Beltsiou, PsyD is a graduate of New York University Postdoctoral Program in Psychoanalysis. She has presented nationally and internationally on the topic of immigration and identity. In 2016, her anthology "Immigration in Psychoanalysis" was published by Routledge. She maintains a private practice in New York City.



Learning Objectives

Participants will:

- **Gain a better understanding of how they and their patients absorb and internalize the tensions or trauma of immigration to a foreign land.**
- **Learn to identify and describe ways of establishing and “finding oneself” when faced with the fragmentation and self-alienation triggered by immigration.**
- **Learn to recognize self-defeating patterns in immigrant patients and ways the clinician can work to help minimize or reverse them.**





Soul to Soul: Keep Psychoanalysis Moving! Clinical Work with Ethnic and Sexual Minorities

Patricia Gherovici, PhD is a psychoanalyst and analytic supervisor. She is co-founder and director of the Philadelphia Lacan Group and Associate Faculty, Psychoanalytic Studies Minor, University of Pennsylvania (PSYS), Honorary Member at IPTAR, and Founding Member of Das Unbehagen. Her books include *The Puerto Rican Syndrome* (Other Press: 2003; Gradiva Award and Boyer



Prize), *Please Select Your Gender: From the Invention of Hysteria to the Democratizing of Transgenderism* (Routledge: 2010) and *Transgender Psychoanalysis: A Lacanian Perspective on Sexual Difference* (Routledge: 2017). She has published two edited volumes (with Manya Steinkoler) *Lacan On Madness: Madness Yes You Can't* (Routledge: 2015) and *Lacan, Psychoanalysis and Comedy* (Cambridge University Press: 2016). Most recently, she published (with Chris Christian) *Psychoanalysis in the Barrios: Race, Class, and the Unconscious* (Routledge: 2019).



Learning Objectives

Participants will learn:

- To identify key patterns of relating, of clinician bias, that interfere with adequate empathic resonance with patients from challenged ethnic and sexual minorities.
- To understand the relationship between the patient's need for unconditional acceptance and the importance of maintaining clinical boundaries to help them develop a sense of safety and identity within themselves through the therapeutic relationship.
- To recognize how unarticulated, or unconscious biases, on the clinician's part can negatively impact the therapeutic process.



Minding Boundaries: Countertransference and Reciprocal Resilience in Clinical Training and Practice

Patricia Bratt is a psychoanalyst, psychotherapist, clinical supervisor practicing in Livingston, NJ and New York City. She is a director of the Academy of Clinical and Applied Psychoanalysis (ACAP), and BGSP-NJ offering a Masters degree in Clinical Mental Health Counseling (MMHC) and in Psychoanalysis (MAP). Dr. Bratt is president of the National Association for Advancement of Psychoanalysis (NAAP) and the NJ Certified Psychoanalysts Advisory Committee. As Director of Applied Psychoanalysis at ACAP she developed its program in Trauma & Resilience Studies, and in 2018 launched the iStrive Center: a weekend program for young adults on the autism spectrum.

Dr. Bratt is faculty and training supervisor at several psychoanalytic institutes, and has been graduate faculty at the Boston Graduate School of Psychoanalysis, Drew University, Centenary College, and Union College. She is the author of articles on group dynamics, stress in relationships, theory of technique, and working with memory impaired trauma victims. She has been a consultant expert on TV and in the news. Her recent book, *Mutual Growth in the Psychotherapeutic Relationship: Reciprocal Resilience*, is published by Routledge (2019).



Learning Objectives

Participants will learn:

- To identify some ways in which countertransference reactions can impact the therapist's therapeutic boundary issues such as: impulsivity, self-revelation, and other forms of acting out behavior.
- About the positive reciprocal loop between clinician and patient that can increase emotional resilience for both.
- To identify parallels between the therapeutic and supervisory relationship, and mutual growth.
- To assess some of the ethical and relational issues arising in the course of clinical training and some means for addressing them in the institute or school settings.



Jennifer R. Harper, MDiv, DD, NcPsyA

Jennifer Harper is Director of the Interfaith Doctor of Ministry program for Pastoral Care at the Hebrew Union College–Jewish Institute for Religion (New York Campus). She is a faculty member at the Blanton-Peale Institute for Religion and Health, and is a former Dean of training in psychoanalysis at the Westchester Institute for Training in Psychoanalysis and Psychotherapy (Bedford Hills NY). She is past-President of the National Association for the Advancement of Psychoanalysis (NAAP), and currently serves as Chair of the American Board for Accreditation in Psychoanalysis, Inc. (ABAP, Inc.)

Ms Harper received the Masters of Divinity degree from Union Theological Seminary in New York City and a Certificate in Psychoanalysis from the Westchester Institute. She is in private practice in New York City and Bergen County, NJ.
