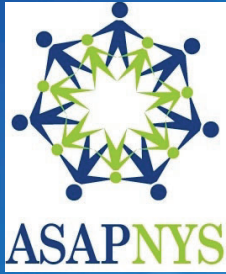

## **POSTER SESSION: MONDAY, APRIL 8, 2019 FROM 3:45-4:45 PM**

On Monday afternoon, there will be a poster presentation & reception for the display of the best prevention approaches in New York State. Information on successful programs, promising approaches, program evaluation, evidence-based practices or research findings are all requested. Your applications for the poster session must clearly demonstrate concrete outcomes to be considered for selection. Collaborations, innovative approaches that are grounded in research are strongly encouraged to enhance educational effectiveness. A printed program with the brief abstract of each poster will be supplied for attendees by the conference host (pending receipt of abstracts by print deadline).

## **PRESENTATION FORMAT**

*The poster session reception will allow the submitter to display and speak to professionals about their projects and research. Plenaries & Workshop presenters have been pre-determined by committee invitation. The 2019 schedule is complete. Each poster presenter must supply their own handouts for their poster (if necessary). Approximately 400 attendees will be present throughout the two day period. Copies made on-site are subject to a charge by hotel.*

## **AREAS OF FOCUS: Please use standard scientific format: Purpose, Methodology, Results, Conclusions and up to 4 references.**

## **REVIEW CRITERIA:**

The Program Committee will review and evaluate proposals submitted based on the following criteria (space is limited):

- Relevance to Prevention
- Level of organization innovation, and discovery represented
- Ability to demonstrate clearly defined outcomes

## **PRESENTATION GUIDELINES**

Each author is allotted a space measuring 4 feet across by 4 feet tall on a tackable surface, at the most. Each tackboard (8' across by 4' wide) is shared by two presentations. You must supply your own presentation supplies, such as push pins and masking tape. The Conference Manager will have a small stock of supplies which can be used in an emergency. **Every poster should come pre-assembled as much as possible to allow for a quick set-up.**

All additional equipment and associated fees, including laptops, audio-visual equipment, TV-VCR combos, and projectors may be allowed if space allows, but they are at the expense of the author. The conference host will not cover any costs associated with the poster sessions other than the tackboard rental. Your own audio-visual equipment may be allowed into the hotel, if your presentation is approved.
