Total Membership: All persons currently listed in church membership records regardless of residence or level of participation

Baptisms: Total number of persons added to the church by baptism during the year

Transfers: Total number of persons added to the church by transferring membership from another congregation

Disciples Women: Total number of women in the congregation who participate in women's ministries

Disciples Men: Total number of men in the congregation who participate in men's ministries
