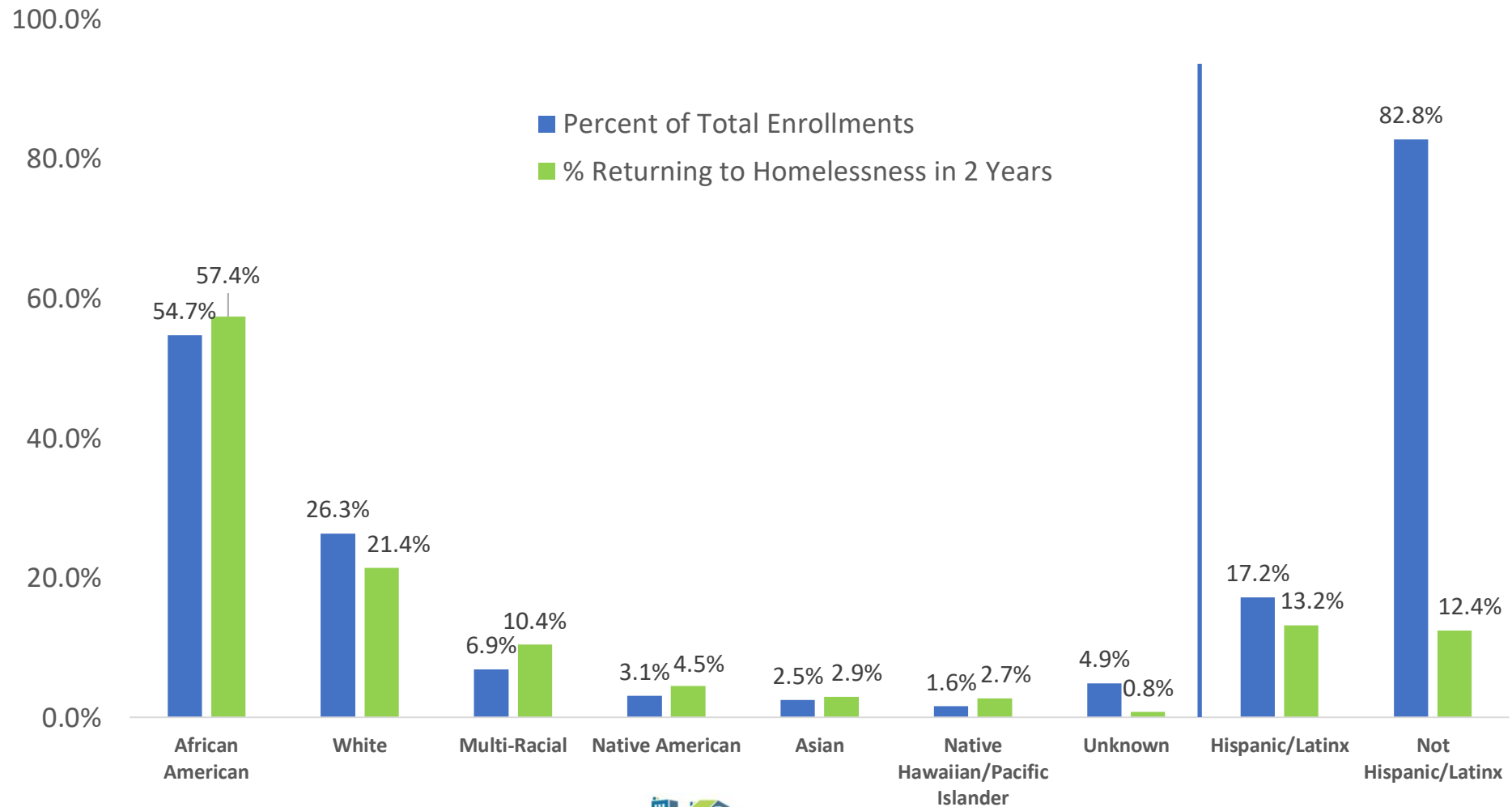

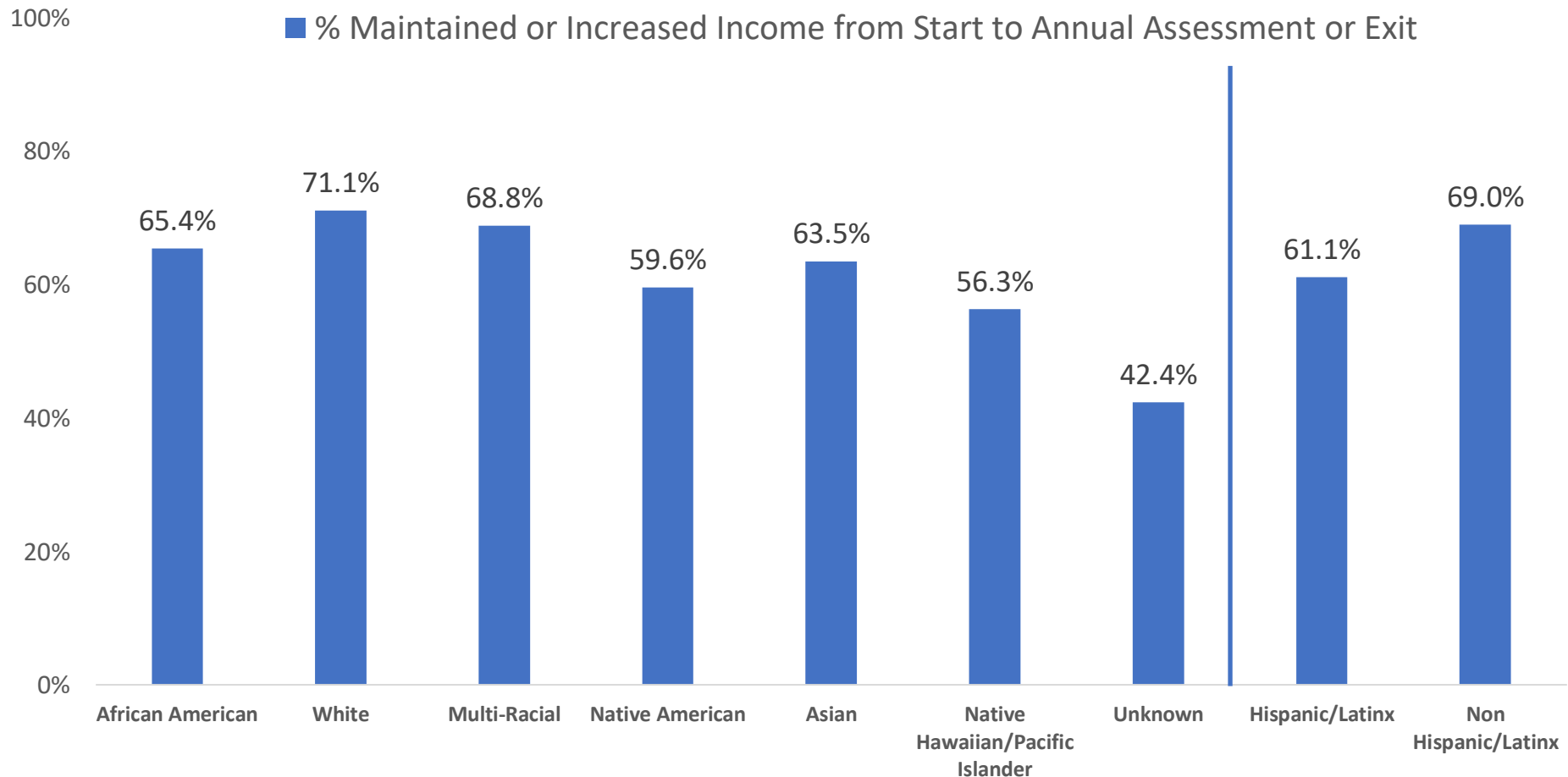

# Coordinated Entry Evaluation: Requirements

- 1) Must be conducted annually
- 2) Participant and provider feedback must be included
- 3) Three components to consider:
  - 1) Compliance Evaluation
  - 2) Effectiveness Evaluation
  - 3) Process Assessment

# Planning Process:

1. System Coordination Committee will be making a decision on where this evaluation work will live and if a subcommittee will be gathered to conduct the evaluation
2. Feedback and ideas shared in this meeting today will be shared with the SCC Committee



# January 2020 Coordinated Entry Evaluation:

- 1) **Two Participant focus groups and interviews**– 25 participants at three regional locations (Oakland, Berkeley and Hayward)
- 2) **Provider process evaluation** – Large and small group in person discussion with coordinated entry providers and funders
- 3) **Analysis of HMIS prioritization data** – demographics, subpopulations and matching
- 4) **Coordinated Entry Self Assessment** – Required by HUD, completed by SCC Committee

# Coordinated Entry Evaluation

- 1) Last evaluation was published **January 2020**
- 2) CoC agreed to postpone evaluation until 2022, but HUD CoC is requesting a plan in February from the SCC Committee
- 3) Aims today – Gather feedback and suggestions on:
  - 1) Who/how the evaluation should be conducted – what key players are needed?
  - 2) Key elements to include in the evaluation
  - 3) Timeline for evaluation

# Recent/Current Evaluation Work on Coordinated Entry 2.0

- 1) **Self assessment** – Completed by HCSA late 2021 – fulfills “compliance” aspect of CE evaluation
- 2) Focus Strategies – currently conducting a **quantitative analysis of the CE assessment tool** to look at scoring and indicated referrals by race/ethnicity. Report expected in February
- 3) HMIS reports – Currently there are some dashboards built to assess components of the system
