Wilma B. Hogan Enduring Community Project Award Winner

Altrusa International of Highland County, OH

Project: Books for all Kids

At the 2025 Convention in Quebec City, the Altrusa International Foundation, Inc., was honored to present the first Wilma B. Hogan Enduring Community Project Award to the Altrusa International Club of Highland County, Inc., Ohio.

This Award is a prestigious recognition given by the Foundation to a Club that has a demonstrated exceptional long-term service project that has had an impact on the community, shown growth and development, and has achieved successful outcomes. This award is a tribute to Wilma B. Hogan, a dedicated member of Altrusa International of Tampa Bay, Florida, Inc. The Altrusa International Club of Highland County's initiative, Books For All Kids, promotes literacy and seeks to change lives one book at a time.

The initial project began with delivering books to students in grades 1, 2, and 4. This project was made possible from fundraising activities and support from the community for those fundraisers, such as the annual Quarter Raffle and Book Sales.

Grants from South Central Power, the Elks, NCB bank, Altrusa International Foundation, and sponsoring a golf tournament opened funds to begin giving books to students in grades K-5. Recently the club has received money from Merchants National Bank, Weastec and Hillsboro Eagles and will be expanding the book project to include preschool and supporting 6th grade teachers with needed literacy materials.

For over 20 years, this impactful initiative has placed more than 27,000 books into the hands of Highland County children promoting literacy, sparking joy, and changing lives one book at a time.

Virginia Smith "Ginny"

Virginia Smith, better known as Ginny, was recognized as the 2025 Anna H Settle Community Leadership Award. She is a member of Altrusa International of Lexington, KY and has long been committed to serving her community through with a particular focus on education and literacy.

Her project, Breckinridge Elementary Magnet School, has a population of 520 students from 28 countries, who speak more than 17 different languages. Ginny recognized the significant special needs of this school and saw an opportunity for the Altrusa Club of Lexington, KY to provide meaningful supplemental support to these students beyond a once-a-year program. Since 2010 Ginny has spearheaded the following projects for Breckinridge:

- · The Dictionary and learning for third grade students
- Books as Bridges Projects promoted literacy, education and global friendships between students from Breckinridge with students in classrooms in Bosnia and Herzegovina and then Tokyo.
- In 2022, a project was developed to bring Altrusa volunteers into each classroom for interactive reading activities and with each student received books for their home libraries.
- Ginny also spearheaded an annual essay contest. Now in its third year the contest is open to 4^{th} grade and 5^{th} classes.
- She has secured two grants totally \$2,500 to secure a Scholastic Book Vending Machine for the school and purchased subscriptions for 3rd, 4th and 5th graders through Storyworks.
- "One School One Book" program for the entire school enrollment is Ginny's most recent project. Each student receives a copy to read at home as a family and at school students can discuss and explore the novel with their classmates. This strategy involves families in their student's learning, bridges home and school connections and creates a community of readers to discuss and share their thoughts.

In his letter of support for Ginny's nomination Principal Price states, "Ms. Smith's work is not driven by accolades or recognition, but by a deep-rooted belief in the limitless potential of every child. She is a true volunteer in every sense of the word, living and leading in our community without compensation, dedicating her time, heart and talents selflessly -- she brings hope, joy, and opportunity to those who need it most. Her leadership is a beacon of the values that the Anna H. Settle Community Leadership Award seeks to honor."

VIP Donor Recognition Reception

One hundred and three Altrusans were invited to attend the VIP Donor Recognition reception held during the 2025 Convention. These Altrusans donated at least \$500 to the Intentional Acts of Giving Campaign and Lamplighter program during the 2023-2025 biennium.

Invited donors enjoyed light refreshments and beverages in the company of fellow honorees as they were recognized and thanked for their generosity. Each donor received a Lamplighter paperweight donated by Doc Morgan, Inc. at the conclusion of the event.

Introducing Club 52:

Honoring Our Legacy, Building the Future



The name Club 21 was chosen in anticipation of the 21st century, which began just three years after Club 21's launch. Now, we celebrate the 30th anniversary of this powerful initiative.

Over the past 30 years, Club 21 has grown from a single camp for children with AIDS/HIV to supporting a wide range of programs for children facing physical, mental, and emotional disabilities, cancer and blood disorders, and other medical and socioeconomic challenges. Our reach now extends even further, encompassing international education and health initiatives.

With this growth, the need—and the cost—has naturally increased. What was once a meaningful \$21 donation in 1997 is equivalent to nearly \$50 in 2025.

At the 59th International Convention in Québec City, we officially transitioned from Club 21 to Club 52. Two Hundred Seventy-Four Altrusans attending the Convention became Charter Members of Club 52. This new chapter invites everyone to contribute **\$1 per week for 52 weeks—or a one-time donation of \$52**—to continue and expand the legacy we've built together.

All who donate from July 2025 through May 31, 2026, including at Spring 2026 District Conferences or via our website—will be recognized as Charter Members of Club 52.

Clubs and Districts contributing **\$252** or more during this period will also be recognized as **Charter Members** and will receive a **Club 52** patch for their banners as a symbol of their commitment and impact.

It was wonderful to meet many of you who attended the Altrusa International Conference in Quebec City, Canada, in July. It is always a positive experience to meet other like-minded individuals from so many places around the globe.

As a member of the Altrusa International Foundation Board of Trustees, I had the privilege of helping to present two workshops on successful grant application preparation and requirements. I was joined by Karen Robinson, Past Chair of the Foundation Board, and by Dr. Kantrice Rose, Executive Director for the Foundation. Attendees were a mix of "first-time" application writers and those with prior experience writing grant requests to the International Foundation. (We even had one attendee via "FaceTime" from India!)

Regardless of the level of grant experience, the message we offered was that the application process has been designed to help your Club "develop a viable project" and to submit a "competitive application".

In closing, we reiterate our willingness to answer questions regarding the Foundation's grant application processes, project in development, or a currently funded project experiencing setbacks.
