

Please note the following change was approved by the board earlier this year!

The monetary award from the Myrtice H. Price award comes from the \$10,000 endowment within District Three. The interest is calculated as of January 31st of each year.

If there is a tie for Second place, the Second and Third place awards are combined and split evenly amongst the winners. If there is a tie for Third place, the Third place award will be split evenly amongst the winners.


#### **Culture & History**

#### The Bee-auty of the Agenda

Robert's Rules of Order Newly Revised dictate meeting procedure at the club and district levels (Club Bylaws Article XVIII and District Bylaws Article XVI). They ensure that meetings are fair, orderly and organized. The meeting agenda reflects these goals and assists in their execution.

The agenda is a critical roadmap for a meeting, not merely a list of discussion topics. Its purpose is to provide structure by listing items in the order they will be discussed to ensure an orderly meeting, increase efficiency by letting attendees know what to expect and what needs to be accomplished, aid in record-keeping by supplementing accurate minutes and ensure accountability by reminding the group of outstanding items for discussion or action and tracking actions taken.

Typically, the president or chair prepares the agenda, often with assistance from the secretary. Distributing the agenda in advance allows participants to prepare for the meeting.

The format, or standard order of business, is as follows:


- CALL TO ORDER
- ADOPTION OF THE AGENDA
- APPROVAL OF THE MINUTES
- · REPORTS OF OFFICERS
- REPORTS OF COMMITTEES
- UNFINISHED BUSINESS
- NEW BUSINESS
- ANNOUNCEMENTS
- ADJOURNMENT

The rules do allow for flexibility. Approval of the agenda often gives permission to the chair to take up items out of order if necessary. Any member may propose a motion to amend the agenda before it is adopted. This motion or one to approve the agenda as presented requires a simple majority vote to pass. Once the agenda is adopted, any member may make a motion to amend it (to add or delete an item, for example). It requires a two-thirds majority vote for approval.

By adhering to this consistent format and procedure, a group can conduct its business effectively and efficiently.



To be eligible for election as a Foundation Trustee, the nominee:

- Must have been a member of Altrusa International, Inc. for a minimum of two (2) years prior to nomination for election and must have served as club president, club foundation chair or club or foundation treasurer.
- Must have been a member of Altrusa International, Inc. for a minimum of five (5) years prior to nomination for election and must have served on a 501(c)3 Foundation Board external to Altrusa.

The term of office for a Trustee or Treasurer is two years. Board members may serve no more than three consecutive terms.

## District Three Club Bylaws Update

District Three Bylaws, Resolutions & Recommendations Chair

At the summer International Conference, two changes to the Altrusa International Bylaws were passed. One of these changes affects Club Bylaws. The YOUNG ADULT category of membership has been added and needs to be inserted in Club Bylaws.

I have asked all Club Presidents in District Three to update their Bylaws and Email me a copy of the updated Club Bylaws by NOVEMBER 26, 2025 or sooner. This Bylaws change does not need a vote by the Club so it is just a matter of updating your Bylaws in Word format. Thanks so much for your attention to this matter. The changed sections are shown in RED below.

#### Article IV. Members

#### Section 1. Members

The members shall include persons who are Active, Young Adult, Emeritus, Honorary and Life members.

#### **Section 2. Active Members**

Except as herein provided, community members who are of good character and who subscribe to the principles and purposes of Altrusa International, Inc. may be invited to become Active members of the Club.

#### Section 3. Young Adult Members

Young adult members are those active members who are age 30 and younger and are eligible for a 50 percent reduction in International Dues from the regular Rate. Any member not willing to document their date of birth will be charged the Full regular rate.

#### Section 4. Emeritus Members

- (a) Emeritus members are those Active members who are no longer able to actively contribute to the Club because of health or other restrictions which limit their activity, provided:
  - (i) The Board of Directors of the Club and the District Board of Directors approve such change in status; and
  - (ii) They have been members of International for ten (10) years; and
  - (iii) They are, through great service to Altrusa and devotion to its Principles, deserving of the honor.
- (b) Emeritus members are not eligible to vote, hold office, or serve on a committee, and have no interest in the property or funds of the Club or District. They are entitled to wear the insignia of International and to attend all meetings. They shall not be required to pay District and International dues. The Club may waive club dues. An Emeritus member will only receive services purchased by the Club.
- (c) An Emeritus member who again is able to participate as an Active member may return to Active status.

#### Section 5. Honorary Members

- (a) The Club may confer honorary membership upon any individual who has achieved distinction through some notable
- (b) Honorary members shall be exempt from all fees and dues, shall not be eligible to vote, hold office, or serve on a committee and shall have no interest in the property or funds of the Club. They shall be entitled to attend all meetings of the Club.
- (c) Honorary members shall not be members or former members of Altrusa.



# District Three Virtual Club - Growing and Doing


The District Three Virtual Club now has 24 members with others in the membership pipeline. For many, we provide an Altrusa home in areas of the country where the opportunity to meet in person does not exist. For others, we are a way to increase networking with more Altrusa members who live not only in District Three but in states outside of the District. We have found ways to provide community service and support literacy in a new format. Recently, we were asked to assist District Nine (Texas) identify strategies that would be helpful as they look to develop a Virtual Club in their District.

We have a quarterly newsletter and received the District Three Award for Outstanding Newsletter at the last conference. We continue, as a group to support Days for Girls and at last count, we have donated 424 panties, 608 pads, 88 bars of soap, and 96 washcloths. We also received a New Club grant from the Altrusa International Foundation in August of 2024 and just completed our report of projects completed with these monies. Examples of projects that we were able to do with grant and individual funding involved provision of school supplies, snacks, and books; flood relief assistance; items for foster children; and support for community service in partnership with organizations such as: Catholic Charities, North Star Family Resource Center, Saving Mercy, and Safe Harbor. Overall the New Club grant helped fund 12 projects.

Currently we are in the process of constructing our first Yearbook, identifying a project or projects which will benefit from a Club fundraiser, and conducting a Strengths, Weaknesses, Opportunities, and Threats (SWOT) analysis that will help us in strategic planning and improvement of Club functioning. At the recommendation of our Membership Development Committee and other members, we have started a Member Minute and will initiate chat rooms to help our members get to know each other better.

We hope our Club can help advance the LOVE, LITERACY, AND LEGACY agenda of our new Altrusa International President, Christine DeVlieger.

In service and literacy, Altrusa's reach goes well beyond traditional boundaries, we are proof of that. Considering joining us! # Kindness Stars in St. Augustine

Wyatt's Kindness Stars have been found all over the world.

When we read about Wyatt and his making and giving these Kindness Stars, we thought what a nice way to spread some kindness here in St Augustine and make them part of our intentional acts of kindness project.

From the Kindness Star's Facebook page, we learned, through Wyatt, how to make the Kindness Stars and where to get the materials to make the stars. We developed our own message to attach to the stars. We also wanted folks to know that the stars were coming from Altrusa St Augustine, so we incorporated that into the message.



We started our Kindness Star Project during the second year of Linda's biennium by just leaving the stars in public places such as grocery stores or libraries. Then we became a little more deliberate and brought the stars to all the events where our Altrusans were volunteering such as The Coconut Barell Christmas Craft Show and the A1A Longest Yard Sale. We also brought them to all the Monday Funday programs we did throughout the school year with the Early Childhood Services Department.
