2019 MS-ISAC "Kids Safe Online" Poster Contest

Attention Educators and Parents:

Students in grades kindergarten through twelve are invited to participate in the Commonwealth of Virginia's *Kids Safe Online* Poster contest. The contest is sponsored by the Virginia Information Technologies Agency (VITA) in conjunction with the Multi-State Information Sharing and Analysis Center (MS-ISAC). This is a national contest which encourages our youth to use the Internet safely and securely. Please forward this information to the individuals in your school district that would be interested in this contest.

Educating our children about the rules of Internet safety will encourage them to make better decisions when posting pictures, videos and personal information online.

The top five winning posters from Virginia for each grade group (K-5, 6-8 and 9-12) will be submitted to the national Multi-State Cyber Security Awareness poster contest. MS ISAC will select a total of 13 winners to have their artwork displayed in the 2020 National Stay Safe Online Calendar which will be distributed throughout the country and used in campaigns to raise awareness among children of all ages about internet and computer safety. The top four submissions will also be made into posters promoting cybersecurity practices. The winning Virginia posters will be featured on our website.

Eligibility

Public, private and home schooled students in grades K-12 are invited to participate for a chance to have their artwork displayed on the 2020 MS-ISAC Posters and Calendar!

Judging Criteria

Posters will be judged on the following criteria:

- Clear message conveyed by the text and artwork
- The poster theme listed is addressed
- Creativity, originality and artistic quality
- Visual clarity - easily read
- Bright and colorful
- Must comply with poster requirements (landscape) layout, does not use copyrighted materials or contain inappropriate content.

Submission Deadline

School entry forms and posters entries must be received by **midnight, Jan. 11, 2019**. Late entries will not be considered

Suggested Topics:

Grades K-5 & 6-8

- How should you treat others online?
- What information is safe to put on social media and what should you keep private?
- How should you handle unwanted attention or strangers online?
- How can you select a strong password and keep it secure?
- How can you handle cyberbullying?

Grades 9-12

- How can you preserve your online reputation or “digital footprint” on both social media and elsewhere on the internet?
- How should you handle unwanted attention or strangers online?
- How can you select a strong password and keep it secure?
- Why is it important to keep your devices and software up to date?
- When is it safe to text and what information is safe to text?

- DO NOT send any artwork that contains trademarked images or brands such as Disney characters, Dell, Google, Twitter, etc.
- Students may use a variety of media such as watercolor, pen and ink, chalk marker etc. ****Note brighter colors reproduce better for the calendar.**
