2026 Teachers Federal Credit Union Scholarship

The Teachers Federal Credit Union Scholarship is awarded annually to ten graduating high school seniors who are attending an accredited college, university, or trade school as full-time students in the U.S.

To be eligible, the student must meet the following criteria:

Graduate from high school in the Spring of 2026

Have a minimum GPA of 3.0

Attending an accredited college, university, or trade school in the Fall of 2026, in the U.S.

Have a minimum GPA of 3.0

The member will be enrolled in either a two- or four-year accredited educational institution

The member agrees to use any scholarship funds awarded by January 31, 2027, at an accredited educational institution only
