**O'Connell Announces Free COVID-19 Test Kits Available to High-Need City Residents**

Taunton, MA... Today Mayor O'Connell announced the City of Taunton will be distributing free COVID-19 test kits to high-need Taunton residents. Last week, the Baker-Polito Administration announced plans to partner with local cities and towns to increase at-home access to COVID-19 test kits for Massachusetts residents.

The Department of Public Health has provided the City of Taunton with 15,570 over the counter at-home rapid antigen test kits. These tests will be made available for distribution to Taunton residents, with an emphasis on increasing access for individuals and families who are facing financial hardship and may otherwise have difficulty purchasing a test kit.

Mayor O'Connell is pleased with the state's efforts to help protect Taunton residents during the holiday season when COVID-19 transmission rates tend to increase. "Testing is a useful tool in stopping the spread of COVID-19. When residents know they have contracted COVID, they can take the appropriate steps to keep themselves and their families safe. At-home testing is easy and convenient. I am grateful to the Department of Public Health and our community partners who continue to work together to prioritize the health and safety of our City residents."

To qualify for a free kit, City residents must currently have COVID-19 symptoms, been directly exposed to someone who tested positive for COVID-19, or are living in a home with a COVID-positive individual. Please note individuals do not need to be tested if they are fully vaccinated and have been exposed to COVID-19 unless they are experiencing COVID-19 symptoms.
