



COVID-19 Emergency Response Grants

Release Date: 12/17/2020

Purpose:

The COVID-19 Emergency Response Grants fund local safety net agencies who are actively responding to meet the basic needs, such as emergency housing, food, child care and other concrete supports.

GWCHF recognizes many non-profit agencies are currently faced with dual challenges—an increase in demand for services as well as marked reduction in fundraising dollars. These Emergency Response Grants will support agencies *currently providing services* who are experiencing:

- an increased demand for services due to the virus
- an increase in expenses in order to safely deliver services within emergency guidelines

Emergency Response grants will not support routine business expenses such as payroll, rent or utilities.

Who Can Apply:

These grants will provide emergency funding support to 501C3 non-profit or governmental agencies aiding individuals in communities served by the Dodgeland, Hustisford, Ixonia, Jefferson, Johnson Creek, Lake Mills, Waterloo and Watertown school districts.

Key Dates and Deadlines:

- Applications will be accepted on an ongoing basis now through June 30, 2021
- Organizations will receive award notification within two weeks of application submission
