To help us keep up with FEMA flood standards and maintain our flood insurance discounts with FEMA's CRS Program, we formed a Floodplain Management Planning Committee, which is led by City Solicitor Paul Baldini and Floodplain Manager Neil Byrne. The committee will be hosting public meetings in Council Chambers at City Hall later this year on Tuesday, October 22, and Tuesday, December 10, at 9:00 a.m. on both days. During the meetings, we hope to share suggestions and gather input from the public so we can continue to move forward as one community and become as flood-resilient as possible.
