Who to Talk to about Immigration Questions?

1. **Pediatrics Inpatient Wards**
 - o Can consult Mobile Immigration Navigator, Jake Savage p0501
 - Phone: 617-414-4624 (Mon-Fri, 9am to 5pm)

 - EPIC: send a message to pool *BMC Amb Immigrant Health Center*
2. **Pediatric Emergency Department**
 - o Defer to ED Social Workers who will collaborate with Immigration Navigator
3. **Pediatric Outpatient Clinics**
 - a. Defer to your clinic's patient navigator or case worker, who can collaborate with Immigration Navigator.
 - b. If patient is primary care patient outside of BMC, defer to social work at their primary care clinic.

2. **Know Your Rights Cards**

Linked on the BMC internal hub. Available in several languages that patients can carry in their wallet. Describes their rights regardless of immigration status in the United States. Patients can show this card if stopped by ICE.
