



DSCSA: Global Location Numbers and DSCSA Compliance Data Preferences

Cardinal Health remains committed to providing you with the latest information as we prepare for Pharmaceutical Tracing requirements that take effect in November 2023.

Take Action: Global Location Number (GLN) Requirement

Obtain your GLN:

- **Customers with 9 or more locations must complete the [Cardinal Health DSCSA GLN Data Collection form](#) by August 1, 2023.**

To date, we have received GLN submissions from 29 percent of customers. **If you do not have a GLN attached to your account, you will be out of compliance, and we will be unable to do business with you or ship product to you after November 27.**

- Customers with fewer than 9 locations will receive a GLN from Cardinal Health; no action is required.

Verify your GLN:

- Your GLN can be found on your paper/pdf invoice.
- If a GLN is not shown on your paper/pdf invoice, it is either still being enumerated by Cardinal Health with GS1 (applicable to customers with fewer than 9 locations) or awaiting action from you (applicable to customers with 9 or more locations).

DSCSA Compliance Data Preferences:

- **Cardinal Health Web Portal:** All customers will have access to DSCSA transaction data via the Cardinal Health Web Portal (Track and Trace Reporting). If you choose this option to receive data, no action is required. More details about the enhanced reporting and how to access DSCSA transaction data after November 2023 will be shared at a later date.
- **EPCIS Solution:** Cardinal Health has selected Antares Vision Group/Rfxcel as the solution provider for DSCSA transaction data via EPCIS. We will reach out to customers who requested to use EPCIS to receive transactional data to initiate the onboarding process. To test and set up



electronic interoperability properly, you will need to either complete the GLN data collection form or the [**Cardinal Health DSCSA EPCIS Solution Provider information \(3rd Party vendor\)**](#) form by **August 1, 2023**. Antares Vision Group/Rfxcel will reach out and schedule testing once you have completed the form.
