Penalties for Non-Compliance

Federal

- Failure to meet any of the requirements is listed under Prohibited Acts (21 USC 331) of the Food, Drug, and Cosmetic Act.
- First offense: Up to 1 year imprisonment and \$1,000 fine
- First offense with intent to defraud or mislead: Up to 3 years imprisonment and \$10,000 fine
- Subsequent offenses: Up to 3 years imprisonment and \$10,000 fine
- Additional charges for mail fraud and misbranding can be filed

State & Local

- State Board of Pharmacy will impose their own sanctions that can include termination of license.
- Pharmaceutical manufacturers and wholesalers can file individual lawsuits against your organization.
