Just like school returns in September and football is the season in the fall, it's time again to turn our heads towards PMDA's 27th Annual Symposium. This year's symposium promises to be unique, educational, informative and relevant for multiple complexities in our industry. As always, a welcome reception will start us off on Thursday with all welcome to attend. Indulge your taste buds while reacquainting with colleagues throughout the Commonwealth.

On Friday, the first day of the conference, we're trying a unique theme: a case presentation will be given for a skilled care patient arriving at a skilled care post-hospital facility. The lecture topics for the morning will be geared to following the patient on entering the facility and travel through multiple departments and the interaction for patient care in generating a skilled care plan to optimize quality patient care treatment. Topics will include a discussion of how to accept a patient in post-acute care from admissions directions. The role of the nurse practitioner will be lectured to enlighten the room on the value of early interaction of evaluation, orders and exams. The morning theme will be completed with "The Role of a Social Worker." Friday after lunch a requested pharmacology lecture will be given on the 2019 updated American Geriatrics Society Beers criteria for potentially inappropriate medication for use in older adults. At 2:30 there will be a medical clinical lecture of updated management of common infections that should be very informative. To finish off Friday, our own President-Elect of AMDA, David Nace, MD, will share with us his annual public policy update that promises to fill the room with energy and valuable information. I recommend wherever you are you should stick around to benefit from Dr. Nace's insight.

Saturday, our second day, promises academic knowledge and intellectual expansion. Our day will start with a lecture on the five articles that could affect your LTC practice. Next, we will be going into a medical disease discussion on a case of hospital readmission. A lecture on monitoring and managing chronic and

We'll then stay on the academic roll and follow with a talk on diabetes with preventing readmissions and appropriate management goals.
