**CONTRIBUTOR INFORMATION:** Contributions are not deductible as charitable donations for federal income tax purposes. All contributions are subject to the limitations of the Federal Election Campaign Act. Only personal and PAC checks or personal credit cards are acceptable. Individuals can contribute \$2,900 to the Primary 2022 Election and \$2,900 to the General 2022 Election. Multicandidate PACS may contribute \$5,000 per election and non-multicandidate PACS may contribute \$2,900 per election. Contributions from corporations, foreign nationals, and federal government contractors are prohibited. Contributions must be made from personal funds and may not be reimbursed by any other person.

**INFORMATION FOR PARTNERSHIPS OR LLCs:** A partnership or limited liability company may not contribute as an entity. However, a check from a partnership or limited liability company may be accepted so long as it is accompanied by a letter allocating the contribution to the individual partner(s) or member(s) and is signed by each contributing partner or member. The letter must include each contributing partner's or member's home address.
