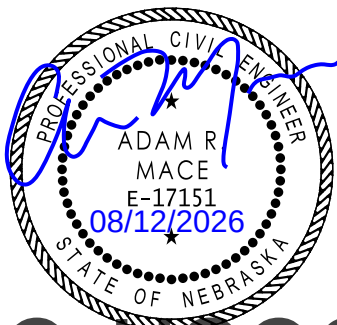

NOTICE TO BIDDERS

Sealed bids will be received by the Nuckolls County Clerk until September 8, 2026, at 9:15 a.m. and will be opened shortly thereafter for supplying materials required to construct corrugated metal pipes with steel headwalls and wingwalls and other related incidental work at three sites. The Bids will be presented to the Board for consideration on September 8, 2026, at their regularly scheduled meeting. The project sites are located; C-65(747) – on Road B between Road 3000 and Road 3100; C-65(749) – on Road 2800 and between Road H and Road J; C-65(750) – on Elkton Street between Road 4050 and Road 4100, all in Nuckolls County, Nebraska.

The project is referred to as “Nuckolls County 2026 Culverts: C-65(747), C-65(749), & C-65(750)” and shall include all labor, materials, transportation, and equipment required to fabricate and deliver the materials to construct: C-65(747) – Twin 132” x 42’ corrugated metal pipes on a 15 deg. skew (lhb); C-65(749) – Triple 72” x 40’ corrugated metal pipe on a 0 deg. skew, C-65(750) – Triple 60” x 42’ round equivalent corrugated metal pipes on a 10-deg. skew (lhb), all with steel headwalls and wingwalls.

Copies of the Bid Documents and Specifications are open to public inspection at the office of the Nuckolls County Clerk, 150 S. Main Street, Nelson, Nebraska 68961. A digital set of bid documents may be obtained from Mainelli Wagner & Associates, Inc. for a non-refundable fee of \$30.00. An optional half-sized paper set of the bid documents is available for a non-refundable fee of \$75.00 (6920 Van Dorn St., Lincoln, Nebraska 68506; PH: 402-421-1717). All Bid Proposals must be submitted on the forms furnished with the Bid Documents.

The sealed bids may be mailed or delivered to the County Clerk of Nuckolls County, County Courthouse, 150 S. Main Street, Nelson, Nebraska 68961, and should be plainly marked as, “Materials Bid Proposal – Nuckolls County 2026 Culverts: C-65(747), C-65(749), & C-65(750)”.

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check made payable to the County Treasurer of Nuckolls County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to include an estimated time of delivery for the materials with their Bid Proposal. The desired delivery date of the materials is ten to twelve weeks after the award of the contract. All materials shall be delivered to the respective project site. Project C-65(747) will be fabricated first of the three sites.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to acceptance by the Nuckolls County Board of Commissioners.

The Nuckolls County Board of Commissioners reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the Contract will be in accordance with the County Purchasing Act’s competitive bidding considerations as set forth in Neb.Rev.Stat. §§ 23-3110 to 23-3114. Nuckolls County is an Equal Opportunity Employer.
