

## **Written Testimony Template in Support of S.210 OR H.1278: An Act Relative to Wheelchair Repair**

I believe we can build a more just and accessible state — one where no one is forced to wait weeks or months to get their mobility back. Please vote yes on S.210 OR H.1278.
- When my wheelchair doesn't work, my entire world stops. That's not something anyone should have to explain, justify, or wait months to fix. I'm asking you — as a person with lived experience — to help make sure that what happened to me doesn't happen to someone else. Please pass S.210 OR H.1278.
- My wheelchair gives me freedom. When it breaks and no one fixes it, that freedom is stolen. S.210 OR H.1278 are about protecting the right to move, to live, and to be treated like everyone else. Pass these bills, and show that disability rights are not optional.
