### **Federal**

- Surgeon General Vivek Murthy said the U.S. is seeing a "proliferation of misinformation online," as false information regarding COVID-19 and vaccinations is being amplified on social media platforms. More info here.
- U.S. Surgeon General Vivek H. Murthy said that he supports individual counties reinstating mask
  mandates to combat local surges of the coronavirus among unvaccinated people as the delta
  variant drives a spike in infections. More info <a href="here">here</a>.
- Public companies and nongovernmental organizations have quietly rolled out passports of their own. American Airlines, United, and The Commons Project Foundation, a digital health nonprofit, have all created their own passports that collect and store data pertaining to the COVID-

19 vaccination status of individuals. This information can be shared with third-party companies, including customs and border officials, business affiliates, contractors, and marketing providers—often for profit. More info here.

• A federal judge in Texas on Friday <u>ruled</u> that Deferred Action for Childhood Arrivals, the Obamaera program shielding certain undocumented immigrants from deportation, is not legal and blocked new applicants. The ruling would bar future applications. It does not immediately cancel current permits for hundreds of thousands of people. More info <u>here</u>.

#### State

• Gov. Gavin Newsom avoided answering a question Monday about whether he might impose a new statewide mask mandate, instead stressing the importance of vaccinations. The rate of Californians testing positive for COVID-19 in the last week, known as the positivity rate, has ticked up steadily for days and is now at 4.1%, the highest it's been since February. Instead, local counties throughout the state has reinstate mask mandates on their own. More info here.

### Local

### **LA County**

- Los Angeles County is now recording more than 10,000 coronavirus cases a week a pace not seen since March — an alarming sign of the dangers the Delta variant poses to people who have not been vaccinated and heightening pressure on health officials to reverse the trend. More info here.
- The Los Angeles County Health Officer Order was modified to require masking for everyone while indoors, regardless of vaccination status. The L.A. County indoor masking requirements for everyone is effective Saturday, July 17 at 11:59 p.m. More info here.
- The Los Angeles County Sheriff announced that his department will not enforce a reinstated mask mandate, saying it is not backed by guidelines from the Centers for Disease Control and Prevention. More info here.

## **Orange County**

 Recently rising COVID-19 cases – particularly since vaccinations rolled out broadly earlier in the year – are being seen in Orange County, in part due to the Delta variant of the virus. The OC Health Care Agency reported an adjusted daily case rate of 2.6 per 100,000 residents. More info here.

# **Infection Prevention Medical Director**

- The recall situation with the Governor may be impacting the way that the mask mandate is being handled. There is a mask mandate in LA County. Please let your friends, community members know that COVID-19 is real it is crucial to wear a mask indoors and in large crowded settings.
- Please ensure that children are wearing their masks avoid indoor gatherings and indoor parties.
- Individuals who are vaccinated will have a less severe reaction to the delta variant, but can still rarely get COVID-19 and spread it to others.

You should be reviewing this file daily to make sure that any employee who is in the office that day has submitted a response. If they have not, send them to the entrance to be screened and enter their results in the survey. The survey is required for everyone who enters any AltaMed building.
